LEGISLATIVE COUNCIL.

PRIVATE BUSINESS.

1. The Perpetual Trustees, Estate, and Agency Company of New Zealand (Limited) Bill—to be further considered in Committee.

Contingent Notice of Motion.

The Honourable Mr. RICHMOND to move, on the motion for third reading of the Perpetual Trustees, Estate, and Agency Company of New Zealand (Limited) Bill, That the Bill be recommitted for the purpose of adding the following clauses:—

To stand clause 9a:—

Trusts moneys to be kept in separate accounts.

The said company shall keep a separate account of all moneys coming into their hands for or on behalf of any trust estate or property held and administered by them; and if any such moneys shall at any time be paid into any bank, it shall be paid to a separate account, to be called a Trusts Account, and such bank shall have notice that the moneys in such account are exclusively moneys of the trust estates or properties held and administered by the said company.

To stand clause 22:—

Companies to be subject to future Acts for control without compensation.

The said company and all other companies acting as trustees under authority of any Act of the General Assembly or otherwise shall be subject to the provisions of any Act that may hereafter be passed by the General Assembly for the regulation of such companies, and no such company shall be entitled to receive any compensation in respect of the operation of any Act which may be so passed whatsoever may be the effect of any such Act in respect to any such company.

To stand clause 23:—

Saving powers of Supreme Court as to trusts.

Nothing in this Act or any previous Act for empowering Trustee Companies contained shall operate to annul or abridge any powers or jurisdiction now possessed by the Supreme Court in respect to trustees, and all such powers and jurisdiction shall apply to the said company and to every such company in respect of all trusts undertaken by them.
