In each year, on the day on which the annual election is held, one-third part of the number of trustees elected by the contributors shall go out of office (but may nevertheless be re-elected), and the persons who shall go out of office shall be those longest in office without re-election; or, where two or more shall have been in office for the same length of time, then those who shall go out of office shall be determined by lot.

Clause 4, line 15. Strike out the word "annual."

- 5. Wages Protection Bill—consideration of the following reasons assigned by the House of Representatives for disagreeing with the amendments of the Legislative Council :--

The Bill as amended provides for contracting-out. This is inimical to the employé, and would lead to abuses on the part of unscrupulous persons who would decline to employ any workman who refused to give a consent in writing to deductions being made from his wages for payment of insurance premiums, and that, perhaps, on a policy unfair in its incidence.

That misrepresentations and abuses on the part of insurance agents have occurred, and the retention of subclause (2) of clause 3 is a necessary precautionary and preventive measure.

without any license or other authority, take or kill, as his own property, any game or native game trespassing or being on such land.

Hon. Mr. ARKWRIGHT to move, That, on the Bill being reported from the Committee of the Whole, the Bill be recommitted for the purpose of adding the following proviso to clause 3 :--

Provided also that it shall be lawful for any person to kill hares at any time of the year on land in his own occupation.
