#### REPORT.

A Mr. James George Wilson is the person beneficially interested in the 100 acres of land described in the Bill. This land was granted in trust to the said James George Wilson under "The Walsh and Others Pension Act, 1869," but he does not come into full possession of the land until he is forty years of age, being now thirty-four.

The Bill proposes to remove the restrictions imposed by the Act of 1869, and vest the land

absolutely in the said James George Wilson when it becomes law.

Your Committee examined James George Wilson, and ascertained from him that the land was now leased for £100 a year, which sum was paid to the Union Bank of Australia to pay interest on an overdraft premium on a life insurance, and the balance retained as a sinking fund to pay off his indebtedness to the bank.

That, owing to these payments, he was unable to profitably carry on his business as a surveyor at Woodville for want of funds, and he proposed to sell the land, for which he could

obtain £1,800, and apply the proceeds as follows, viz. :-

The balance of £500 he proposes to invest on mortgage as an aid to income.
