BROADCASTING CORPORATION OF NEW ZEALAND RESTRUCTURING BILL

Proposed Motion to Divide the Bill into 3 Bills

Hon. JONATHAN HUNT, in Committee, to move as follows:

That clauses 3 to 22A, and the First to Fifth Schedules, be a separate Bill, and that for clause 3 there be substituted the following Title, enacting words, and clauses:

An Act-

- (a) To dissolve the Broadcasting Corporation of New Zealand; and
- (b) To provide for the vesting in the Crown of the assets and liabilities of the Broadcasting Corporation of New Zealand; and
- (c) To provide for the transfer from the Crown to Radio New Zealand Limited and Television New Zealand Limited of assets and liabilities vested in the Crown on the dissolution of the Broadcasting Corporation of New Zealand; and
- (d) To enable the Secretary of Trade and Industry to collect the public broadcasting fee in the period beginning with the date of the dissolution of the Broadcasting Corporation of New Zealand and ending with the close of the 30th day of June 1989; and
- (e) To amend the Broadcasting Act 1976, the Broadcasting Regulations 1977, and certain other Acts

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Broadcasting Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Broadcasting Act 1976 (hereinafter referred to as the principal Act).
- (2) This Act shall come into force on the 1st day of December 1988.
 - 2. Act to bind the Crown—This Act shall bind the Crown.

That clauses 23 to 29 and the Sixth Schedule, be a separate Bill, and that for clause 23 there be substituted the following Title, enacting words, and clause:

An Act to amend the State-Owned Enterprises Act 1986 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the State-Owned Enterprises Amendment Act (No. 4) 1988, and shall be read together with and deemed part of the State-Owned Enterprises Act 1986 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it

receives the Royal assent.

That clauses 30 to 38, and the Seventh Schedule, be a separate Bill, and that for clause 30 there be substituted the following Title, enacting words, and clauses:

An Act to provide for the incorporation of a company to be known as New Zealand Symphony Orchestra Limited

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the New Zealand Symphony Orchestra Act 1988.
- (2) This Act shall come into force on the day on which it receives the Royal assent.
 - 2. Act to bind the Crown—This Act shall bind the Crown.

EXPLANATORY NOTE

This Supplementary Order Paper contains the appropriate motion to split the Broadcasting Corporation of New Zealand Restructuring Bill into 3 separate Bills—the Broadcasting Amendment Bill (No. 2), the State-Owned Enterprises Amendment Bill (No. 4), and the New Zealand Symphony Orchestra Bill.
