NOTICES RELATING TO ORDERS OF THE DAY.

COUNTIES ACT 1876 AMENDMENT BILL (No. 2).

Mr. SHRIMSKI, in Committee, to move the insertion of the following subsection:—

- (a.) To prescribe the width of tires of wheels of vehicles now or hereafter running upon the roads in the county.

MUNICIPAL CORPORATIONS BILL.

Mr. STEWART, in Committee, to move the addition of the following new clause:—

The Council of a borough may extend any existing street in a borough, and such extension may be of the same width as the street of which such extension is intended to form a part.

Mr. STEVENS, in Committee, to move the insertion of the following new clause instead of clause 2:—

2. In addition to the subjects mentioned in the three hundred and forty-ninth section of "The Municipal Corporations Act, 1876," the Council may make by-laws on the following subjects:—

- (1.) To prevent or regulate the blasting of any rock, stone, or timber within the borough.
- (2.) To prevent or regulate the placing of obstructions of any kind whatsoever upon any wharf, street, river, or public place within the borough.
- (3.) To prevent or regulate the placing of any writing or printing, or in any other way defacing any house, building, fence, or other erection whatsoever within the borough.
- (4.) For compelling the cleaning of any private yards or places of any kind whatsoever within the borough.
- (5.) For preventing the drowning of any animal, or the throwing of any offensive matter or matters likely to produce a nuisance, in any well, creek, river, or other water or water-course within the borough.
- (6.) For punishing the driver of any vehicle or of any animal, or the rider of any animal, who, by negligence of any kind, injures any person or property within the borough.
- (7.) To prevent the driving of any dog or goat in harness in the borough.
- (8.) For preventing and punishing any person driving or riding any animal without sufficient reins, or without being competent so to ride or drive, or driving or having the sole charge of more than one vehicle at a time.
- (9.) For punishing any driver or rider who, in passing other drivers or riders, or foot passengers, does not observe the rule of the road.

- (10.) For punishing any person who shall incite any dog to attack or annoy any person within the borough, or shall suffer any dangerous dog to be at large within the borough.
- (11.) For punishing the breaking of any windows in any building within the borough.
- (12.) To provide for the licensing of all rooms and places used as public shooting-galleries, bowling-alleys, skittle-grounds, billiard-rooms, bagatelle-rooms, or any public rooms or places used for the playing of any other kind of game, unless the same be in or attached to any premises holding an hotel license; and to make such regulations as the Council shall think fit respecting the use, inspection, hours of opening and closing, and in all respects as to the conduct of such rooms or places.
- (13.) To prevent and punish the keeping and maintaining, or in any way the assisting in the keeping or maintaining, whether by letting the premises, or in any other way whatsoever, of any house as a disorderly house, brothel, or house of ill-fame.
- (14.) To compel the owner or occupier of any land or premises in which there is any gully or hollow place, upon due notice from the Council, either to fill up the same or to clean it.
- (15.) Generally to prevent in any portion of the borough all nuisances, and all practices tending to endanger the lives of or to frighten or annoy the public.
