

SUPPLEMENTARY ORDER PAPER.

HOUSE OF REPRESENTATIVES.

WELLINGTON ELECTRIC LIGHTING BILL.

Mr. MACDONALD, on the consideration of the Report of the Wellington Electric Lighting Bill, to move, That, with a view to the consideration of the sub-joined proposed new clauses, the Bill be recommitted to the former Committee, that the Committee be revived, and that they have leave to sit and proceed thereon:—

1. This Act shall not come into force unless the Burgesses of the City of Wellington shall, within three months from the passing of the Act, express their approval of it, and their desire that its provisions should be adopted.

2. That such approval shall be expressed by the Corporation publishing in the borough once in each week for four successive weeks a notice setting forth—

- (1.) The name of the Act and the nature of the works proposed to be undertaken under its authority;
- (2.) The names of the parties receiving the concession, and the amount or nature of the consideration the citizens are to receive from such parties for the rights ceded to them under the Act;

and calling a meeting of the Burgesses to consider the said Act, and after such meeting taking a poll of the Burgesses in the same manner as is provided for by sections one hundred and seventy-nine to one hundred and eighty-three inclusive of Part IX. of "The Municipal Corporations Act, 1886," in reference to loans.

CHRISTCHURCH ELECTRIC LIGHTING BILL.

Mr. MACDONALD, on the consideration of the Report of the Christchurch Electric Lighting Bill, to move, That, with a view to the consideration of the sub-joined proposed new clauses, the Bill be recommitted to the former Committee, that the Committee be revived, and that they have leave to sit and proceed thereon:—

1. This Act shall not come into force unless the Burgesses of the City of Christchurch shall, within three months from the passing of the Act, express their approval of it, and their desire that its provisions should be adopted.

2. That such approval shall be expressed by the Corporation publishing in the borough once in each week for four successive weeks a notice setting forth—

- (1.) The name of the Act and the nature of the works proposed to be undertaken under its authority;
- (2.) The names of the parties receiving the concession, and the amount or nature of the consideration the citizens are to receive from such parties for the rights ceded to them under the Act;

and calling a meeting of the Burgesses to consider the said Act, and after such meeting taking a poll of the Burgesses in the same

manner as is provided for by sections one hundred and seventy-nine to one hundred and eighty-three inclusive of Part IX. of "The Municipal Corporations Act, 1886," in reference to loans.

FISHERIES CONSERVATION BILL.

Mr. JOYCE, in Committee, to move the following amendment:—

It is hereby provided that when any auctioneer or other fish-salesman shall have been fined for buying, selling, exposing for sale, or having in possession any fish or oyster in contravention of the said Act, he or they may recover in any Resident Magistrate's Court the fine and costs imposed, together with a sum not exceeding *five pounds* as and by way of ascertained damages, from the fisherman or other person at or near the said sea, river, or lake who sent or supplied such fish and oyster for sale.
