DEPARTMENT OF LABOUR Proposed Motion to Divide the Bill into 9 Bills

Hon. STAN RODGER, in Committee, to move the following amendments:

That *clauses 3 to 5* be a separate Bill; and that for *clause 3* there be substituted the following Title, enacting words, and clause:

An Act to amend the Construction Act 1959

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Construction Amendment Act 1989, and shall be read together with and deemed part of the Construction Act 1959 (hereinafter referred to as the principal Act).

That *clauses 6 to 9* be a separate Bill; and that for *clause 6* there be substituted the following Title, enacting words, and clause:

An Act to amend the Dangerous Goods Act 1974 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Dangerous Goods Amendment Act 1989, and shall be read together with and deemed part of the Dangerous Goods Act 1974 (hereinafter referred to as the principal Act).

That *clauses 10 to 12* be a separate Bill; and that for *clause 10* there be substituted the following Title, enacting words, and clause:

An Act to amend the Explosives Act 1957

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Explosives Amendment Act 1989, and shall be read together with and deemed part of the Explosives Act 1957 (hereinafter referred to as the principal Act).

That *clauses 13 and 14* be a separate Bill; and that for *clause 13* there be substituted the following Title, enacting words, and clause:

An Act to amend the Factories and Commercial Premises Act 1981 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Factories and Commercial Premises Amendment Act 1989, and shall be read together with and deemed part of the Factories and Commercial Premises Act 1981 (hereinafter referred to as the principal Act).

That *clauses 15 and 16* be a separate Bill; and that for *clause 15* there be substituted the following Title, enacting words, and clause:

An Act to amend the Immigration Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Immigration Amendment Act 1989, and shall be read together with and deemed part of the Immigration Act 1987 (hereinafter referred to as the principal Act).

That *clauses 17 and 18* be a separate Bill; and that for *clause 17* there be substituted the following Title, enacting words, and clause:

An Act to amend the Machinery Act 1950

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Machinery Amendment Act 1989, and shall be read together with and deemed part of the Machinery Act 1950 (hereinafter referred to as the principal Act).

That *clauses 19 and 20* be a separate Bill; and that for *clause 19* there be substituted the following Title, enacting words, and clause:

An Act to amend the Shop Trading Hours 1977 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Shop Trading Hours Amendment Act 1989, and shall be read together with and deemed part of the Shop Trading Hours Act 1977 (hereinafter referred to as the principal Act).

That *clauses 21 to 23* be a separate Bill; and that for *clause 21* there be substituted the following Title, enacting words, and clause:

An Act to amend the Industrial Training Levies Act 1978 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Industrial Training Levies Amendment Act 1989, and shall be read together with and deemed part of the Industrial Training Levies Act 1978 (hereinafter referred to as the principal Act).
