FINANCE BILL (NO. 2)

Proposed Motion to Divide Bill into 25 Bills

Hon. DAVID CAYGILL, in Committee, to move as follows:

That *clauses 1 to 12* be a separate Bill; and that for *clause 1* and the heading "PART I BONUS BONDS" there be substituted the following Title, enacting words, and clause:

An Act to make provision with respect to public finances and other matters

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Finance Act (No. 2) 1990.

(2) Except as provided in **sections 10 (2), 11 (2), and 12 (2)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 13 to 35* and the *First and Second Schedules* be a separate Bill; and that for *clause 13* there be substituted the following Title, enacting words, and clause:

An Act to amend the Social Security Act 1964

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—(1) This Act may be cited as the Social Security Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Social Security Act 1964 (hereinafter referred to as the principal Act).

(2) Except as provided in **sections 23 (5), 24 (2), 26 (3), 27 (3), 28 (3), 29 (2), 31 (2), 33 (3), 34 (2), and 35 (3)** of this Act, this Act shall be deemed to have come into force on the 25th day of July 1990.

That *clauses 36 to 40* be a separate Bill; and that for *clause 36* there be substituted the following Title, enacting words, and clause:

An Act to amend the Social Welfare (Transitional Provisions) Act 1990

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Social Welfare (Transitional Provisions) Amendment Act 1990, and shall be read together with and deemed part of the Social Welfare (Transitional Provisions) Act 1990 (hereinafter referred to as the principal Act).

That *clauses 41 and 42* be a separate Bill; and that for *clause 41* there be substituted the following Title, enacting words, and clause:

An Act to repeal the America's Cup (Planning) Act 1989
BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the America's Cup (Planning) Act Repeal Act 1990.

That *clauses 43 to 57* be a separate Bill; and that for *clause 43* there be substituted the following Title, enacting words, and clause:

An Act to amend the Government Superannuation Fund Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Government Superannuation Fund Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Government Superannuation Fund Act 1956 (hereinafter referred to as the principal Act).

(2) Except as provided in **sections 46 (3), 47 (2), 49 (2), 50 (2), 51 (6), and 54 (2)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 58 to 60* be a separate Bill; and that for *clause 58* there be substituted the following Title, enacting words, and clause:

An Act to amend the State Sector Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the State Sector Amendment Act 1990, and shall be read together with and deemed part of the State Sector Act 1988 (hereinafter referred to as the principal Act).

That *clauses 61 to 63* be a separate Bill; and that for *clause 61* there be substituted the following Title, enacting words, and clause:

An Act to amend the Area Health Boards Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Area Health Boards Amendment Act 1990, and shall be read together with and deemed part of the Area Health Boards Act 1983 (hereinafter referred to as the principal Act).

That *clauses 64 and 65* be a separate Bill; and that for *clause 64* there be substituted the following Title, enacting words, and clause:

An Act to amend the Superannuation Schemes Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Superannuation Schemes Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Superannuation Schemes Act 1989 (hereinafter referred to as the principal Act).

That *clauses 66 to 76* be a separate Bill; and that for *clause 66* there be substituted the following Title, enacting words, and clause:

An Act to amend the Export Guarantee Act 1964

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Export Guarantee Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Export Guarantee Act 1964 (hereinafter referred to as the principal Act).

(2) Except as provided in section 76 (2) of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 77 and 78* be a separate Bill; and that for *clause 77* there be substituted the following Title, enacting words, and clause:

An Act to amend the Plant Variety Rights Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Plant Variety Rights Amendment Act 1990, and shall be read together with and deemed part of the Plant Variety Rights Act 1987 (hereinafter referred to as the principal Act).

That *clauses 79 to 82* be a separate Bill; and that for *clause 79* there be substituted the following Title, enacting words, and clause:

An Act to amend the State-Owned Enterprises Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the State-Owned Enterprises Amendment Act (No. 3) 1990, and shall be read together with and deemed part of the State-Owned Enterprises Act 1986 (hereinafter referred to as the principal Act).

That *clauses 83 and 84* be a separate Bill; and that for *clause 83* there be substituted the following Title, enacting words, and clause:

An Act to amend the Commerce Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Commerce Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Commerce Act 1986 (hereinafter referred to as the principal Act).

That *clauses 85 and 86* be a separate Bill; and that for *clause 85* there be substituted the following Title, enacting words, and clause:

An Act to amend the Fisheries Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Fisheries Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Fisheries Act 1983 (hereinafter referred to as the principal Act).

That *clauses 87 and 88* be a separate Bill; and that for *clause 87* there be substituted the following Title, enacting words, and clause:

An Act to amend the Marine Farming Act 1971

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Marine Farming Amendment Act 1990, and shall be read together with and deemed part of the Marine Farming Act 1971 (hereinafter referred to as the principal Act).

That *clauses 89 to 95* be a separate Bill; and that for *clause 89* there be substituted the following Title, enacting words, and clause:

An Act to amend the Tourist and Publicity Department Act 1963

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Tourism Department Amendment Act 1990, and shall be read together with and deemed part of the Act heretofore known as the Tourist and Publicity Department Act 1963 (hereinafter referred to as the principal Act).

That *clauses 96 to 99* and the *Third Schedule* be a separate Bill; and that for *clause 96* there be substituted the following Title, enacting words, and clause:

An Act to amend the Tariff Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Tariff Amendment Act 1990, and shall be read together with and deemed part of the Tariff Act 1988 (hereinafter referred to as the principal Act).

(2) Except as provided in **section 98 (6)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 100 to 111* and the *Fourth Schedule* be a separate Bill; and that for *clause 100* there be substituted the following Title, enacting words, and clause:

An Act to amend the Customs Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Customs Amendment Act 1990, and shall be read together with and deemed part of the Customs Act 1966 (hereinafter referred to as the principal Act).

(2) Except as provided in **sections 103 (3), 104 (2), 105 (2), 106 (2), 109 (3), 110 (4), and 111 (5)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 112 and 113* be a separate Bill; and that for *clause 112* there be substituted the following Title, enacting words, and clause:

An Act to amend the Immigration Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Immigration Amendment Act 1990, and shall be read together with and deemed part of the Immigration Act 1987 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day after the day on which it receives the Royal assent.

That *clauses 114 to 147* and the *Fifth Schedule* be a separate Bill; and that for *clause 114* there be substituted the following Title, enacting words, and clause:

An Act to amend the Income Tax Act 1976

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—(1) This Act may be cited as the Income Tax Amendment Act (No. 3) 1990, and shall be read together with and deemed part of the Income Tax Act 1976 (hereinafter referred to as the principal Act).

(2) Except as otherwise provided in this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 148 to 152* and the *Sixth to Eighth Schedules* be a separate Bill; and that for *clause 148* there be substituted the following Title, enacting words, and clause:

An Act to abolish land tax with effect on and from the year of payment commencing on the 1st day of April 1992, and to provide for matters relating to land tax during the period ending with the 31st day of March 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Land Tax Abolition Act 1990.

(2) Except as provided in **section 151 (5)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 153 to 161* be a separate Bill; and that for *clause 153* there be substituted the following Title, enacting words, and clause:

An Act to amend the Goods and Services Tax Act 1985

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Goods and Services Tax Amendment Act 1990, and shall be read together with and deemed part of the Goods and Services Tax Act 1985 (hereinafter referred to as the principal Act).

(2) Except as otherwise provided in this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 162 to 189* be a separate Bill; and that for *clause 162* there be substituted the following Title, enacting words, and clause:

An Act to amend the Electric Power Boards Act 1925

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Electric Power Boards Amendment Act 1990, and shall be read together with and deemed part of the Electric Power Boards Act 1925 (hereinafter referred to as the principal Act).

That *clauses 190 to 194* be a separate Bill; and that for *clause 190* there be substituted the following Title, enacting words, and clause:

An Act to amend the Electricity Act 1968

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Electricity Amendment Act 1990, and shall be read together with and deemed part of the Electricity Act 1968 (hereinafter referred to as the principal Act).

That *clauses 195 to 197* be a separate Bill; and that for *clause 195* there be substituted the following Title, enacting words, and clause:

An Act to amend the Reserve Bank of New Zealand Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Reserve Bank of New Zealand Amendment Act 1990, and shall be read together with and deemed part of the Reserve Bank of New Zealand Act 1989 (hereinafter referred to as the principal Act).

That *clauses 198 to 202* be a separate Bill; and that for *clause 198* there be substituted the following Title, enacting words, and clause:

An Act to amend the Medicines Act 1981

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Medicines Amendment Act 1990, and shall be read together with and deemed part of the Medicines Act 1981 (hereinafter referred to as the principal Act).

EXPLANATORY NOTE

The motion set out in this Supplementary Order Paper divides the Finance Bill (No. 2) into 25 separate Bills.
