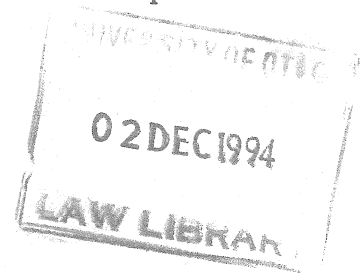

FINANCE BILL (NO. 2)

Proposed Motion to divide Bill into 8 Bills

RIGHT HON. W. F. BIRCH, in Committee, to move as follows:

That *Part III* be a separate Bill; and that for the heading "PART III COMMERCE" and *clause 11* there be substituted the following Title, enacting words, and clause:

An Act to amend the Commerce Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. **Short Title**—This Act may be cited as the Commerce Amendment Act 1994, and shall be read together with and deemed part of the Commerce Act 1986 (hereinafter referred to as the principal Act).

That *Part V* be a separate Bill; and that for the heading "Part V CUSTOMS" and *clause 16* there be substituted the following Title, enacting words, and clause:

An Act to amend the Customs Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. **Short Title**—This Act may be cited as the Customs Amendment Act 1994, and shall be read together with and deemed part of the Customs Act 1966.

That *Part VII* be a separate Bill; and that for the heading "Part VII HEALTH" and *clause 27* and there be substituted the following Title, enacting words, and clause:

An Act to amend the Health Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. **Short Title**—This Act may be cited as the Health Amendment Act (No. 2) 1994, and shall be read together with and deemed part of the Health Act 1956 (hereinafter referred to as the principal Act).

That *Part VIIA* be a separate Bill; and that for the heading "PART VIIA HUMAN RIGHTS" and *clause 29A* and there be substituted the following Title, enacting words, and clause:

An Act to amend the Human Rights Act 1993

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Human Rights Amendment Act 1994, and shall be read together with and deemed part of the Human Rights Act 1993 (hereinafter referred to as the principal Act).

That *Part IX* be a separate Bill; and that for the heading "PART IX RESOURCE MANAGEMENT" and *clause 32* and there be substituted the following Title, enacting words, and clause:

An Act to amend the Resource Management Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Resource Management Amendment Act 1994, and shall be read together with and deemed part of the Resource Management Act 1991 (hereinafter referred to as the principal Act).

That *Part XI* be a separate Bill; and that for the heading "PART XI STATE-OWNED ENTERPRISES" and *clause 39* there be substituted the following Title, enacting words, and clause:

An Act to amend the State-Owned Enterprises Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the State-Owned Enterprises Amendment Act 1994, and shall be read together with and deemed part of the State-Owned Enterprises Act 1986 (hereinafter referred to as the principal Act).

That *Part XII* be a separate Bill; and that for the heading "PART XII FISHERIES" and *clause 43* and there be substituted the following Title, enacting words, and clause:

An Act to amend the Fisheries Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Fisheries Amendment Act (No. 2) 1994, and shall be read together with and deemed part of the Fisheries Act 1983 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 15th day of September 1994
