FINANCE BILL (NO. 4)

Proposed Motion to Divide Bill into 10 Bills

Hon. MAURICE MCTIGUE, in Committee, to move as follows:

That *Part I* and the *First Schedule* be a separate Bill; and that for the heading "PART I NEW ZEALAND EXPORT-IMPORT CORPORATION DISSOLUTION" there be substituted the following Title, enacting words, and clause:

An Act to dissolve the New Zealand Export-Import Corporation and to provide for matters incidental thereto

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Export-Import Corporation Dissolution Act 1992.

That *Part II* be a separate Bill; and that for the heading "PART II AMENDMENTS TO OFFICIAL INFORMATION ACT 1982" and *clause 11* there be substituted the following Title, enacting words, and clause:

An Act to amend the Official Information Act 1982

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Official Information Amendment Act 1992, and shall be read together with and deemed part of the Official Information Act 1982 (hereinafter referred to as the principal Act).

That *Part III* be a separate Bill; and that for the heading "PART III AMENDMENTS TO OMBUDSMEN ACT 1975" and *clause 14* there be substituted the following Title, enacting words, and clause:

An Act to amend the Ombudsmen Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Ombudsmen Amendment Act 1992, and shall be read together with and deemed part of the Ombudsmen Act 1975 (hereinafter referred to as the principal Act).

That *Part IV* be a separate Bill; and that for the heading "PART IV AMENDMENT TO RESERVES ACT 1977" and *clause 17* there be substituted the following Title, enacting words, and clause:

An Act to amend the Reserves Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Reserves Amendment Act 1992, and shall be read together with and deemed part of the Reserves Act 1977 (hereinafter referred to as the principal Act).

That *Part V* and the *Second Schedule* be a separate Bill; and that for the heading "PART V AMENDMENTS TO STATE-OWNED ENTERPRISES ACT 1986" and *clause 19* there be substituted the following Title, enacting words, and clause:

An Act to amend the State-Owned Enterprises Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the State-Owned Enterprises Amendment Act 1992, and shall be read together with and deemed part of the State-Owned Enterprises Act 1986 (hereinafter referred to as the principal Act).

(2) Except as provided in **subsection (3)** of this section, this Act shall come into force on the day on which it receives the Royal assent.

(3) **Sections 28c to 28g** of this Act shall come into force on a day to be appointed by the Governor-General by Order in Council, and one or more Orders in Council may be made bringing different provisions into force on different days.

(4) A day may be appointed pursuant to **subsection (3)** of this section for bringing **section 28e** or **section 28f** of this Act into force only if the Governor-General is satisfied, at the time of the making of the Order in Council, that at least 50 percent of the ordinary shares in the capital of MCS Limited are no longer held by Ministers of the Crown on behalf of the Crown.

(5) A day may be appointed pursuant to **subsection (3)** of this section for bringing **section 28g** of this Act into force only if the Governor-General is satisfied, at the time of the making of the Order in Council, that none of the ordinary shares in the capital of MCS Limited is held by Ministers of the Crown on behalf of the Crown.

That *Part VI* be a separate Bill; and that for the heading "PART VI AMENDMENTS TO TRANSPORT SERVICES LICENSING ACT 1989" and *clause 29* there be substituted the following Title, enacting words, and clause:

An Act to amend the Transport Services Licensing Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Transport Services Licensing Amendment Act 1992, and shall be read together with and deemed part of the Transport Services Licensing Act 1989 (hereinafter referred to as the principal Act).

That *Part VII* be a separate Bill; and that for the heading "PART VII AMENDMENTS TO VETERINARY SURGEONS ACT 1956" and *clause 31* there be substituted the following Title, enacting words, and clause:

An Act to amend the Veterinary Surgeons Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Veterinary Surgeons Amendment Act (No. 2) 1992, and shall be read together with and deemed part of the Veterinary Surgeons Act 1956 (hereinafter referred to as the principal Act).

That *Part VIII* be a separate Bill; and that for the heading "PART VIII AMENDMENT TO CUSTOMS ACT 1966" and *clause 34* there be substituted the following Title, enacting words, and clause:

An Act to amend the Customs Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Customs Amendment Act 1992, and shall be read together with and deemed part of the Customs Act 1966 (hereinafter referred to as the principal Act).

That *Part IX* be a separate Bill; and that for the heading "PART IX AMENDMENT TO FISHERIES ACT 1983" and *clause 37* there be substituted the following Title, enacting words, and clause:

An Act to amend the Fisheries Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Fisheries Amendment Act 1992, and shall be read together with and deemed part of the Fisheries Act 1983 (hereinafter referred to as the principal Act).

That *Part X* be a separate Bill; and that for the heading "PART X AMENDMENT TO RESERVE BANK OF NEW ZEALAND ACT 1989" and *clause 39* there be substituted the following Title, enacting words, and clause:

An Act to amend the Reserve Bank of New Zealand Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Reserve Bank of New Zealand Amendment Act 1992, and shall be read together with and deemed part of the Reserve Bank of New Zealand Act 1989 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 8th day of April 1992.
