FAIR TRADING BILL

Proposed Amendments

Hon. MARGARET SHIELDS, in Committee, to move the following amendments:

Clause 1: To omit subclause (2) (lines 16 and 17 on page 2), and substitute the following subclause:

(2) Except as provided in section 44 (2A) of this Act, this Act shall come into force on the 1st day of March 1987.

Clause 13: To omit paragraph (a) of subclause (1) (lines 37 to 39 on page 9), and substitute the following paragraph:

(a) Falsely represent that a person has any sponsorship, approval, endorsement, or affiliation; or

Clause 23: To omit from subclause (3) the expression "section 12 (a) or (d)" (line 6 on page 17), and substitute the expression "section 12 (a), (d), or (j)".

Clause 28: Subclause (5): To omit the words "No person shall supply or offer to supply goods" (line 23 on page 25), and substitute the words "No person shall supply, or offer to supply, or advertise to supply, goods".

Clause 37: To omit from subclause (1) the words "subject to subsection (2) of this section" (line 36 on page 32).

Clause 44: To omit subclause (2) (lines 4 and 5 on page 44), and substitute the following subclauses:

(2) The enactments specified in Part A of the Second Schedule to this Act are hereby repealed with effect from the commencement of this Act.

(2A) The enactments specified in Part B of the Second Schedule to this Act are hereby repealed with effect from the 1st day of May 1987.

EXPLANATORY NOTE

The amendment to *clause 1* alters the date for the commencement of the Bill from 1 January 1987 to 1 March 1987.

The amendments to *clauses 13, 23, 28, and 37* are of a drafting nature.

The amendment to *clause 44* defers the repeal of the Wool Labelling Act 1949 and the Safety of Children's Night Clothes Act 1977 until 1 May 1987.
