CIVIL SERVICE INSURANCE BILL.

The Hon. Mr. WARD, in Committee, to move the following amendment:—
Clause 4, subsection 9: Omit the words "other than," and substitute "and";
and after subsection (9) insert,—

(9A.) Women and girls employed in the telegraph or telephone

service of the Government.

After clause 5, insert new clause:-

5A. The Governor, by Order in Council, from time to time may make, alter, or revoke any regulations required for the due adminis-

tration of this Act, and for all matters in relation thereto.

Clause 8: Omit all the words at the beginning before "every"; omit the word "shall" before "within such period," and substitute "may at his option, and"; and after "shall," before "be entitled," insert "then"; and in last line but one of the clause, after "the provisions of," insert "sections eleven and twelve of."

Clause 9 to be omitted, and the following substituted:—

9. (1.) With respect to officers who have been appointed as last aforesaid, and who may not elect to avail themselves of the provisions

of section seven of this Act; and

(2.) With respect to officers who may hereafter be appointed to the Civil Service, and have attained a certain age, to be determined by the Governor in Council, which would render it inexpedient or impossible that they should effect policies providing for the combined

insurance and annuity benefits as aforesaid:

Every such officer shall elect, within such period as may be determined by the Governor in Council, either to have the deductions provided for in section eleven of the said Act accumulated in the Public Trust Office, in which case the provisions of sections eleven and twelve of the said Act shall remain in full force with respect to such officer, or to have such deductions applied, together with the amount accumulated at his credit in the Public Trust Office, towards the payment of the premiums on a policy issued under the Acts and regulations in force relating to the Government Life Insurance Department.

After clause 9 insert new clause:—

9a. Nothing in this Act contained shall be construed to annul, limit, or repeal the provisions of sections six to thirteen of "The Government Insurance and Annuities Act, 1874."

Clause 13, lines 44, 45: Omit the words "in consequence of the exercise of any of the powers aforesaid," and in lieu thereof insert the following: "from any cause whatever other than his own default or misconduct."

Clause 18: After subsection (2), insert the following:—

(2A.) All women and girls employed in the telegraph or telephone service of the Government.

KAITANGATA RELIEF FUND TRANSFER ACT AMENDMENT BILL.

The Hon. Mr. Seddon to move the following new clause:—

The Public Trustee is hereby authorised to pay out of the funds of the trust any incidental expenses that may be incurred by the Board in the performance of the duties devolving upon it.
