LICENSING BILL.

Sir W. FOX, in Committee, to move the insertion of the following new clauses:—

No certificate for any sort of license shall be granted if a memorial against the granting of the same, signed by a majority of the ratepayers within the district, shall be presented to the Licensing Committee; the genuineness of such signatures to be verified on oath, or declaration in the nature of an oath, before the Committee by the person or persons in whose presence the same may have been signed. Such memorial to be in the form contained in Schedule hereto appended.

If such memorial shall not contain a sufficient number of signatures the Court shall exercise its discretion in granting or refusing such certificate under the provisions of this Act, as if no such memorial had been presented: Provided that such memorial shall be deposited with the Clerk of the Licensing Committee at least *seven* days before the day appointed for the sitting at which the application to which it refers is to be heard.

Any person who may have been injured either in person, property, means of maintenance, or otherwise, by the drunkenness, habitual or casual, of any other person, may sue for and recover full damages from any dealer in intoxicating liquors who shall habitually, or in the particular instance from which the damage may have arisen, have sold intoxicating liquors to the person whose drunkenness shall have caused such injury, and it shall not be necessary to prove that the person so sued was the only one or the last who had supplied such intoxicating liquors in the particular case.

Mr. TOLE, in Committee, to move the following amendments:—

Clause 27. To insert after "License No. (4)," line 44, the words "Confectioners' licenses."

After clause 31, to add the following new clause:—

A confectioner's license shall authorize every person who shall keep a refreshment house, and shall pursue therein the trade or business of a confectioner, or shall keep open such house as an eating-house for the purpose of selling victuals to be consumed therein, to sell liquor to be consumed with such victuals during such times between the hours of eight in the morning and eight at night, as the Licensing Committee shall determine: Provided such licensee shall not keep any public bar or tap-room on such premises.

In clause 108, to insert after (5), "For a confectioner's license, *ten* pounds."
