EXPLANATORY NOTE

Clause 1, subclause (1): This is a formal amendment only.

Clause 1, subclause (2): These amendments make it clear that if notice of a poll other than an election has been given before the commencement of the Act, the poll is to be held in accordance with the existing provisions, and the amendments made by the Bill will not apply.

Clause 1A: The effect of the amendments made by this clause to the several enactments specified in the Schedule proposed to be added is to reduce from 20 years to 18 years the minimum age for voting at local authority elections and polls and the minimum age for elective members of local authorities.

Separate provision is made in the case of city, borough, and town councils by amendments to the Municipal Corporations Amendment (No. 2) Bill contained in a Supplementary Order Paper to that Bill, and in the case of county councils by amendments to the Counties Amendment Bill contained in a Supplementary Order Paper to that Bill.

Clause 11 (4): These amendments are consequential on the provisions of the proposed new section 21 (as amended in the Local Bills Committee) requiring any party affiliations claimed by candidates to be shown in the public notice of election given under that section.
