### **Local Government Law Reform Bill (No 3)**

Proposed motion to divide Bill into 7 Bills

Hon Chris Carter, in Committee, to move as follows:

That the enacting words, clauses 1 and 2 and Part 1 be a separate Bill, and that for the enacting words, clauses 1 and 2, the Part 1 heading, and clause 3 there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

- Title
- This Act is the Chatham Islands Council Amendment Act (1)
- In this Act, the Chatham Islands Council Act 19951 is called (2)"the principal Act". 1 1995 No 41

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That Part 2 and Schedule 1AA be a separate Bill, and that for the Part 2 heading and clause 6 there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

- This Act is the Dog Control Amendment Act 2004. (1)
- In this Act, the Dog Control Act 19962 is called "the principal Act". <sup>2</sup> 1996 No 13

- 2 Commencement
- (1) Sections 13 and 13A come into force on 1 November 2004.
- (2) Section 18 (except in relation to section 69A(2A) of the principal Act) comes into force on 1 July 2006.
- (3) Section 18 (in relation to section 69A(2A) of the principal Act) and the rest of this Act come into force on the day after the date on which the Act receives the Royal assent.

That *Part 3* be a separate Bill, and that for the *Part 3* heading and *clause 21* there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

- 1 Title
- (1) This Act is the Local Electoral Amendment Act 2004.
- (2) In this Act, the Local Electoral Act 2001<sup>3</sup> is called "the principal Act".

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 4* and *Schedule 1A* be a separate Bill, and that for the *Part 4* heading and *clause 37* there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

- 1 Title
- (1) This Act is the Local Government Act 2002 Amendment Act 2004.
- (2) In this Act, the Local Government Act 2002<sup>4</sup> is called "the principal Act".

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That Part 4A be a separate Bill, and that for the Part 4A heading and clause 57C there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

- 1 Title
- (1) This Act is the Local Government Act 1974 Amendment Act 2004.
- (2) In this Act, the Local Government Act 1974<sup>5</sup> is called "the principal Act".

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That Part 5 be a separate Bill, and that for the Part 5 heading and clause 58 there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

#### 1 Title

- (1) This Act is the Local Government Official Information and Meetings Amendment Act 2004.
- (2) In this Act, the Local Government Official Information and Meetings Act 1987<sup>6</sup> is called "the principal Act".

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That Part 6 and Schedule 1 be a separate Bill, and that for the Part 6 heading and clause 61 there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

#### 1 Title

- (1) This Act is the Local Government (Rating) Amendment Act
- (2) In this Act, the Local Government (Rating) Act 2002<sup>7</sup> is called "the principal Act".

#### 2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

This Supplementary Order Paper proposes to divide the Local Government Law Reform Bill (No 3) into the following 7 Bills:

- Chatham Islands Council Amendment Bill
- Dog Control Amendment Bill
- Local Electoral Amendment Bill
- Local Government Act 2002 Amendment Bill
- Local Government Act 1974 Amendment Bill
- Local Government Official Information and Meetings Amendment Bill
- Local Government (Rating) Amendment Bill.
