LOCAL GOVERNMENT REFORM BILL

Proposed Motion to Divide the Bill into 13 Bills

Hon. Dr MICHAEL BASSETT, in Committee, to move that the Bill be divided into 13 separate Bills as follows:

That Part I, the Second and Third Schedules, and Schedule 3A be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Government Act 1974

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Local Government Amendment Act (No. 5) 1989, and shall be read together with and deemed part of the Local Government Act 1974 (hereinafter referred to as the principal Act).

(2) Except as otherwise provided in this Act, this Act shall come into force on the day on which it receives the Royal assent.

That Part II be a separate Bill, and that for clause 21 there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Elections and Polls Act 1976

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Local Elections and Polls Amendment Act 1989 (No. 2), and shall be read together with and deemed part of the Local Elections and Polls Act 1976 (hereinafter referred to as the principal Act).

(2) Except as otherwise provided in this Act, this Act shall

come into force on the 1st day of July 1989.

That Part III be a separate Bill, and that for clause 31 there be substituted the following Title, enacting words, and clause:

An Act to amend the Electoral Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Electoral Amendment Act 1989, and shall be read together with and deemed part of the Electoral Act 1956 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1989.

That clauses 36 to 44 be a separate Bill, and that for clause 36 there be substituted the following Title, enacting words, and clause:

An Act to amend the Area Health Boards Act 1983 BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Area Health Boards Amendment Act (No. 4) 1989, and shall be read together with and deemed part of the Area Health Boards Act 1983 (hereinafter referred to as the principal Act).
 - (2) This Act shall come into force on the 1st day of July 1989.

That clauses 45 to 54, and Schedule 3B, be a separate Bill, and that for clause 45 there be substituted the following Title, enacting words, and clause:

An Act to amend the Civil Defence Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Civil Defence Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the Civil Defence Act 1983 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of

November 1989.

That *clauses 55 to 69* be a separate Bill, and that for *clause 55* there be substituted the following Title, enacting words, and clause:

An Act to amend the Electric Power Boards Act 1925 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Electric Power Boards Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the Electric Power Boards Act 1925 (hereinafter referred to as the principal Act).

That clauses 70 to 72 be a separate Bill, and that for clause 70 there be substituted the following Title, enacting words, and clause:

An Act to amend the Higher Salaries Commission Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Higher Salaries Commission Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the Higher Salaries Commission Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of

November 1989.

That *clauses 73 to 80* be a separate Bill, and that for *clause 73* there be substituted the following Title, enacting words, and clause:

An Act to amend the Hospitals Act 1957

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Hospitals Amendment Act (No. 4) 1989, and shall be read together with and deemed part of the Hospitals Act 1957 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1989.

That *clauses 81 and 82* be a separate Bill, and that for *clause 81* there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Authorities Loans Act 1956 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Local Authorities Loans Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the Local Authorities Loans Act 1976 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of

November 1989.

That clauses 83 to 92 be a separate Bill, and that for clause 83 there be substituted the following Title, enacting words, and clause:

An Act to amend the Rating Powers Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Rating Powers Amendment Act 1989, and shall be read together with and deemed part of the Rating Powers Act 1988 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of

November 1989.

That *clauses 93 to 96* be a separate Bill, and that for *clause 93* there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Government Official Information and Meetings Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Local Government Official Information and Meetings Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the Local Government Official Information and Meetings Act 1987 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of

November 1989.

That clauses 97 to 99 be a separate Bill, and that for clause 97 there be substituted the following Title, enacting words, and clause:

An Act to amend the Survey Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Survey Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Survey Act 1986 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of

November 1989.

That clauses 100 to 104 be a separate Bill, and that for clause 100 there be substituted the following Title, enacting words, and clause:

An Act to amend the Valuation of Land Act 1951

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Valuation of Land Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Valuation of Land Act 1951 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of November 1989.
