LAW REFORM (MISCELLANEOUS PROVISIONS) BILL Proposed Motion to Divide the Bill into 49 Separate Bills

Hon. W. P. JEFFRIES, in Committee, to move as follows:

That clauses 2 to 4 be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and clause:

An Act to amend the Accident Compensation Act 1982

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Accident Compensation Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Accident Compensation Act 1982 (hereinafter referred to as the principal Act).

That clauses 5 to 14 be a separate Bill, and that for clause 5 there be substituted the following Title, enacting words, and clause:

An Act to amend the Alcoholic Liquor Advisory Council Act 1976

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Alcoholic Liquor Advisory Council Amendment Act 1989, and shall be read together with and deemed part of the Alcoholic Liquor Advisory Council Act 1976 (hereinafter referred to as the principal Act).

That clauses 15 to 20 be a separate Bill, with the following Title, enacting words, and clause:

An Act to reform the law relating to liability for damage caused by animals

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Animals Law Reform Act 1989.

That clauses 21 and 22 be a separate Bill, and that for clause 21 there be substituted the following Title, enacting words, and clause:

An Act to amend the Arms Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Arms Amendment Act 1989, and shall be read together with and deemed part of the Arms Act 1983 (hereinafter referred to as the principal Act).

That clauses 23 to 25 be a separate Bill, and that for clause 23 there be substituted the following Title, enacting words, and clause:

An Act to amend the Building Societies Act 1965 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Building Societies Amendment Act 1989, and shall be read together with and deemed part of the Building Societies Act 1965 (hereinafter referred to as the principal Act).

That clauses 26 and 27 be a separate Bill, and that for clause 26 there be substituted the following Title, enacting words, and clause:

An Act to amend the Carriage of Goods Act 1979

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Carriage of Goods Amendment Act 1989, and shall be read together with and deemed part of the Carriage of Goods Act 1979 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of December 1989.

That clauses 28 to 36B be a separate Bill, and that for clause 28 there be substituted the following Title, enacting words, and clause:

An Act to amend the Companies Act 1955

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Companies Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the Companies Act 1955 (hereinafter referred to as the principal Act).

That clauses 37 and 38 be a separate Bill, and that for clause 37 there be substituted the following Title, enacting words, and clause:

An Act to amend the Copyright Act 1962

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Copyright Amendment Act 1989, and shall be read together with and deemed part of the Copyright Act 1989 (hereinafter referred to as the principal Act).

That clauses 39 to 41 be a separate Bill, and that for clause 39 there be substituted the following Title, enacting words, and clause:

An Act to amend the Crimes Act 1961

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Crimes Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Crimes Act 1961 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1990.

That clauses 42 to 54 be a separate Bill, with the following Title, enacting words, and clause:

An Act to make better provision for the punishment of crimes of torture, and to implement the Convention Against Torture and Other Cruel, Inhuman, or Degrading Treatment or Punishment

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Crimes of Torture Act 1989.

That clauses 55 to 58 be a separate Bill, and that for clause 55 there be substituted the following Title, enacting words, and clause:

An Act to amend the Criminal Justice Act 1985

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—(1) This Act may be cited as the Criminal Justice Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Criminal Justice Act 1985 (hereinafter referred to as the principal Act).

(2) Except as provided in subsection (3) of this section, this section and the next 5 succeeding sections shall come into force on the date on which this Act receives the Royal assent.

(3) Section 56B of this Act shall come into force on the 1st day of April 1990.

That clauses 59 and 60 be a separate Bill, and that for clause 59 there be substituted the following Title, enacting words, and clause:

An Act to amend the Dental Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Dental Amendment Act 1989, and shall be read together with and deemed part of the Dental Act 1988 (hereinafter referred to as the principal Act).

That clauses 61 to 70 and the First Schedule be a separate Bill, and that for clause 61 there be substituted the following Title, enacting words, and clause:

An Act to amend the District Courts Act 1947

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the District Courts Amendment Act (No. 2) 1989, and shall be read together with and deemed part of the District Courts Act 1947 (hereinafter referred to as the principal Act). (2) Except as provided in subsections (3) and (4) of this section,

(2) Except as provided in subsections (3) and (4) of this section, this Act shall come into force on the day on which it receives the Royal assent.

(3) Section 66 of this Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

(4) Section 69 of this Act shall come into force on the 1st day of January 1990.

That clauses 71 to 74 be a separate Bill, and that for clause 71 there be substituted the following Title, enacting words, and clause:

An Act to amend the Evidence Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Evidence Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Evidence Act 1908 (hereinafter referred to as the principal Act).

(2) Sections 76 and 77 of this Act shall come into force on the 1st day of January 1990.

(3) Except as provided in subsection (2) of this section, this Act shall come into force on the date on which it receives the Royal assent.

That clauses 81 and 82 be a separate Bill, and that for clause 81 there be substituted the following Title, enacting words, and clause:

An Act to amend the Export Guarantee Act 1964

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Export Guarantee Amendment Act 1989, and shall be read together with and deemed part of the Export Guarantee Act 1964 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1990.

That clause 106 be a separate Bill, with the following Title, enacting words, and clause:

An Act to repeal the Infants Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Infants Act Repeal Act 1989.

An Act to amend the Life Insurance Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Life Insurance Amendment Act 1989, and shall be read together with and deemed part of the Life Insurance Act 1908 (hereinafter referred to as the principal Act).

That clauses 125 to 130 be a separate Bill, and that for clause 125 there be substituted the following Title, enacting words, and clause:

An Act to amend the Litter Act 1979

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Litter Amendment Act 1989, and shall be read together with and deemed part of the Litter Act 1979 (hereinafter referred to as the principal Act).

That clauses 135 to 137 be a separate Bill, and that for clause 135 there be substituted the following Title, enacting words, and clause:

An Act to amend the Motor Vehicle Dealers Act 1975 BE IT ENACTED by the Parliament of New Zealand as follows:
