Law Reform (Epidemic Preparedness) Bill

Proposed amendments

Hon Pete Hodgson, in Committee, to move as follows:

Clause 22

To omit from proposed *new section* 74B(3)(b) "notifiable disease stated in the notice (or, if 2 or more notices are in force, to the notifiable" at lines 25 to 27 on page 36 and substitute "quarantinable disease stated in the notice (or, if 2 or more notices are in force, to the quarantinable".

Clause 23

To omit proposed *new section* 97(2) (lines 19 to 27 on page 39) and substitute the following:

- "(2) This subsection applies to a person liable to quarantine if the Medical Officer of Health believes or suspects, on reasonable grounds,—
 - "(a) that he or she is infected with a quarantinable disease; or
 - "(b) that, within the 14 days before he or she arrived in New Zealand, he or she has been exposed to a disease that (whether or not it was a quarantinable disease at the time of the believed or suspected exposure) is a quarantinable disease.

To insert "promptly" in proposed *new section* 97A(3) after "so" at line 14 on page 40.

To omit from proposed *new section* 97D(1) "liable to quarantine by virtue of **section** 97(2)" at lines 29 and 30 on page 41 and substitute "to whom **section** 97(2) applies".

To omit *paragraphs* (a) to (c) of proposed *new section* 97D(1) (lines 32 to 36 on page 41) and substitute the following:

"(a) require the person to be examined:

SOP No 82

- "(b) require to be taken from the person any bodily sample the officer may reasonably require:
- "(c) require to be taken from the craft or any thing in or on it any reasonable sample the officer may require:

To omit proposed *new section* 97E(1) (lines 14 to 18 on page 42) and substitute the following:

- "(1) This subsection applies to a person if-
 - "(a) section 97(2) applies to him or her; or
 - "(b) he or she is liable to quarantine and has been quarantined under section 70(1)(f).

To omit from proposed *new section* 97E(3) "liable to quarantine by virtue of **section** 97(2)" at lines 25 and 26 on page 42 and substitute "to whom **subsection** (1) applies".

Explanatory note

The amendments to proposed *new sections 97 and 97E* of the principal Act and the first amendment to proposed *new section 97D(1)* clarify the relationship between those provisions.

The amendment to proposed *new section* 97A(3) of the principal Act makes clear that a person required under that section to collect or supply information must do so promptly.

The second amendment to proposed *new section* 97D(1) has the effect that the power of the Medical Officer of Health to take a sample from or examine a person liable to quarantine, or take a sample from a craft carrying a person liable to quarantine, becomes a power to undertake the examination or sampling himself or herself or to have the examination or sampling undertaken by some other person.
