LAW REFORM (MISCELLANEOUS PROVISIONS) BILL (No. 2)

Proposed Motion to Divide the Bill into 36 Bills

Right Hon. Geoffrey Palmer, in Committee, to move as follows:

That clauses 2 to 7 be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Administration Act 1969

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Administration Amendment Act 1987, and shall be read together with and deemed part of the Administration Act 1969 (hereinafter referred to as the principal Act).

That clauses 8 to 10 be a separate Bill, and that for clause 8 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Alcoholic Liquor Advisory Council Act 1976

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Alcoholic Liquor Advisory Council Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the Alcoholic Liquor Advisory Council Act 1976 (hereinafter referred to as the principal Act).

That clauses 11 and 12 be a separate Bill, and that for clause 11 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Civil List Act 1979

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Civil List Amendment Act 1987, and shall be read together with and deemed part of the Civil List Act 1979 (hereinafter referred to as the principal Act).

That clauses 13 and 14 be a separate Bill, and that for clause 13 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Companies Act 1955

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Companies Amendment Act 1987, and shall be read together with and deemed part of the Companies Act 1955 (hereinafter referred to as the principal Act).

That clauses 15 and 16 be a separate Bill, and that for clause 15 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Constitution Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Constitution Amendment Act 1987, and shall be read together with and deemed part of the Constitution Act 1986 (hereinafter referred to as the principal Act).

That clauses 17 to 19 be a separate Bill, and that for clause 17 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Development Finance Corporation of New Zealand Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Development Finance Corporation of New Zealand Amendment Act 1987, and shall be read together with and deemed part of the Development Finance Corporation of New Zealand Act 1986 (hereinafter referred to as the principal Act).

That clauses 20 and 21 be a separate Bill, and that for clause 20 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Domestic Protection Act 1982 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Domestic Protection Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the Domestic Protection Act 1982 (hereinafter referred to as the principal Act).

That clauses 22 to 31 and the First Schedule be a separate Bill, and that for clause 22 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Act heretofore known as the Electrical Supply Authorities Association Act 1930

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Electricity Supply Association Amendment Act 1987, and shall be read together with and deemed part of the Act heretofore known as the Electrical Supply Authorities Association Act 1930 (hereinafter referred to as the principal Act).

That clauses 32 and 33 be a separate Bill, and that for clause 32 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Evidence Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Evidence Amendment Act (No. 3) 1987, and shall be read together with and deemed part of the Evidence Act 1908 (hereinafter referred to as the principal Act).

That clauses 34 and 35 be a separate Bill, and that for clause 34 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Fees and Travelling Allowances Act 1951

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Fees and Travelling Allowances Amendment Act 1987, and shall be read together with and deemed part of the Fees and Travelling Allowances Act 1951 (hereinafter referred to as the principal Act).

That clauses 36 to 40 be a separate Bill, and that for clause 36 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Films Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Films Amendment Act 1987, and shall be read together with and deemed part of the Films Act 1983 (hereinafter referred to as the principal Act).

That clauses 41 and 42 be a separate Bill, and that for clause 41 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Fire Service Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Fire Service Amendment Act (No. 5) 1987, and shall be read together with and deemed part of the Fire Service Act 1975 (hereinafter referred to as the principal Act).

That clauses 43 and 44 be a separate Bill, and that for clause 43 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Friendly Societies and Credit Unions Act 1982

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Friendly Societies and Credit Unions Amendment Act 1987, and shall be read together with and deemed part of the Friendly Societies and Credit Unions Act 1982 (hereinafter referred to as the principal Act).

That clauses 45 to 49 be a separate Bill, and that for clause 45 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Gaming and Lotteries Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Gaming and Lotteries Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the Gaming and Lotteries Act 1977 (hereinafter referred to as the principal Act).

That clauses 50 to 56 and the Second Schedule be a separate Bill, and that for clause 50 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Geneva Conventions Act 1958 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Geneva Conventions Amendment Act 1987, and shall be read together with and deemed part of the Geneva Conventions Act 1958 (hereinafter referred to as the principal Act).

That clauses 57 and 58 be a separate Bill, and that for clause 57 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Industrial Societies Act 1908 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Industrial Societies Amendment Act 1987, and shall be read together with and deemed part of the Industrial Societies Act 1908 (hereinafter referred to as the principal Act).

That clauses 59 and 60 be a separate Bill, and that for clause 59 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Insolvency Act 1967

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Insolvency Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the Insolvency Act 1967 (hereinafter referred to as the principal Act).

That clauses 61 and 62 be a separate Bill, and that for clause 61 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Judicature Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Judicature Amendment Act (No. 3) 1987, and shall be read together with and deemed part of the Judicature Act 1908 (hereinafter referred to as the principal Act).

That clauses 63 and 64 be a separate Bill, and that for clause 63 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Lincoln College Act 1961

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Lincoln College Amendment Act 1987, and shall be read together with and deemed part of the Lincoln College Act 1961 (hereinafter referred to as the principal Act).

That clauses 65 to 67 and the Third Schedule be a separate Bill, and that for clause 65 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Local Government Act 1974 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Local Government Amendment Act (No. 5) 1987, and shall be read together with and deemed part of the Local Government Act 1974 (hereinafter referred to as the principal Act).

That clauses 68 and 69 be a separate Bill, and that for clause 68 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Massey University Act 1963 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Massey University Amendment Act 1987, and shall be read together with and deemed part of the Massey University Act 1963 (hereinafter referred to as the principal Act).

That clauses 70 and 71 be a separate Bill, and that for clause 70 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Matrimonial Property Act 1976 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Matrimonial Property Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the Matrimonial Property Act 1976 (hereinafter referred to as the principal Act).

That clauses 72 to 74 be a separate Bill, and that for clause 72 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the New Zealand Export-Import Corporation Act 1974

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Export-Import Corporation Amendment Act 1987, and shall be read together with and deemed part of the New Zealand Export-Import Corporation Act 1974 (hereinafter referred to as the principal Act).

That clauses 75 to 77 be a separate Bill, and that for clause 75 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Passports Act 1980

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Passports Amendment Act 1987, and shall be read together with and deemed part of the Passports Act 1980 (hereinafter referred to as the principal Act).

That clauses 78 and 79 be a separate Bill, and that for clause 78 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Recreation and Sport Act 1986 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Recreation and Sport Amendment Act 1987, and shall be read together with and deemed part of the Recreation and Sport Act 1986 (hereinafter referred to as the principal Act).

That clauses 80 and 81 be a separate Bill, and that for clause 80 there be substituted the following Title, enacting words, and Short Title clause:

## An Act to amend the Securities Transfer Act 1977 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Securities Transfer Amendment Act 1987, and shall be read together with and deemed part of the Securities Transfer Act 1977 (hereinafter referred to as the principal Act).

That clauses 82 to 114 be a separate Bill, and that for clause 82 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Trade Marks Act 1953

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Trade Marks Amendment Act 1987, and shall be read together with and deemed part of the Trade Marks Act 1953 (hereinafter referred to as the principal Act).

(2) Sections 83 to 114 of this Act shall come into force on the 1st

day of May 1988.

(3) Notwithstanding subsection (2) of this section, an application for the registration of a trade mark in respect of services may be made at any time after the 1st day of February 1988 and before the coming into force of sections 83 to 114 of this Act as if those sections had come into force on the 1st day of February 1988, but every such application shall be treated as having been made immediately after the coming into force of those sections.

That clauses 115 and 116, and clause 117 (as inserted by Supplementary Order Paper No. 128), be a separate Bill, and that for clause 115 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the Trustee Companies Management Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Trustee Companies Management Amendment Act 1987, and shall be

read together with and deemed part of the Trustee Companies Management Act 1975 (hereinafter referred to as the principal Act).

That clauses 118 and 119 be a separate Bill, and that for clause 118 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Unit Trusts Act 1960

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Unit Trusts Amendment Act 1987, and shall be read together with and deemed part of the Unit Trusts Act 1960 (hereinafter referred to as the principal Act).

That clauses 120 and 121 be a separate Bill, and that for clause 120 there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the University of Auckland Act 1961 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the University of Auckland Amendment Act 1987, and shall be read together with and deemed part of the University of Auckland Act 1961 (hereinafter referred to as the principal Act).

That clauses 122 and 123 be a separate Bill, and that for clause 122 there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the University of Canterbury Act 1961 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the University of Canterbury Amendment Act 1987, and shall be read together with and deemed part of the University of Canterbury Act 1961 (hereinafter referred to as the principal Act).

That clauses 124 and 125 be a separate Bill, and that for clause 124 there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the University of Otago Act 1961
BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the University of Otago Amendment Act 1987, and shall be read together with and deemed part of the University of Otago Act 1961 (hereinafter referred to as the principal Act).

That clauses 126 and 127 be a separate Bill, and that for clause 126 there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the University of Waikato Act 1961 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the University of Waikato Amendment Act 1987, and shall be read together with and deemed part of the University of Waikato Act 1961 (hereinafter referred to as the principal Act).

That clauses 128 and 129 be a separate Bill, and that for clause 128 there be substituted the following Title, enacting words, and Short Title clause:

### An Act to amend the University of Wellington Act 1961 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the University of Wellington Amendment Act 1987, and shall be read together with and deemed part of the University of Wellington Act 1961 (hereinafter referred to as the principal Act).

That clauses 130 to 132 be a separate Bill, and that for clause 130 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to repeal the Wages Protection and Contractors' Liens Act 1939 and to make provision incidental thereto

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Wages Protection and Contractors' Liens Act Repeal Act 1987.

That clauses 133 and 134 (as added by Supplementary Order Paper No. 125) be a separate Bill, and that for clause 133 there be substituted the following Title, enacting words, and Short Title clause:

#### An Act to amend the Trespass Act 1980

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Trespass Amendment Act 1987, and shall be read together with and deemed part of the Trespass Act 1980 (hereinafter referred to as the principal Act).
