# Supplementary Order Paper

Wednesday, 15 March 1995

LAW REFORM (MISCELLANEOUS PROVISIONS) BILL (NO. 3)

*Proposed Motion to divide Bill into 10 Bills*

Hon. D. A. M. GRAHAM in Committee, to move as follows:

That *clauses 19 to 21* be a separate Bill; and that for *clause 19* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Customs Act 1966**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Customs Amendment Act 1995, and shall be read together with and deemed part of the Customs Act 1966 (hereinafter referred to as the principal Act).

That *clauses 22 and 23* be a separate Bill; and that for *clause 22* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Disputes Tribunals Act 1988**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Disputes Tribunals Amendment Act 1995, and shall be read together with and deemed part of the Disputes Tribunals Act 1988 (hereinafter referred to as the principal Act).

That *clauses 25A and 25B* be a separate Bill; and that for *clause 25A* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Evidence Act 1908**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Evidence Amendment Act 1995, and shall be read together with and deemed part of the Evidence Act 1908 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

That *clauses 26 and 27* be a separate Bill; and that for *clause 26* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Forestry Rights Registration Act 1983**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Forestry Rights Registration Amendment Act 1995, and shall be read together

with and deemed part of the Forestry Rights Registration Act 1983 (hereinafter referred to as the principal Act).

That *clauses 28 to 35* be a separate Bill; and that for *clause 28* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Forests Act 1949**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Forests Amendment Act 1995, and shall be read together with and deemed part of the Forests Act 1949 (hereinafter referred to as the principal Act).

That *clauses 47 and 48* be a separate Bill; and that for *clause 47* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Land Transfer Act 1952**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Land Transfer Amendment Act 1995, and shall be read together with and deemed part of the Land Transfer Act 1952.

That *clauses 49 and 50* be a separate Bill; and that for *clause 49* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Law Practitioners Act 1982**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Law Practitioners Amendment Act 1995, and shall be read together with and deemed part of the Law Practitioners Act 1982 (hereinafter referred to as the principal Act).

That *clauses 59 to 62* be a separate Bill; and that for *clause 59* there be substituted the following Title, enacting words, and clause:

**An Act to repeal the Newspapers and Printers Act 1955, and for matters incidental thereto**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Newspapers and Printers Act Repeal Act 1995.

(2) This Act shall come into force on the 28th day after the day on which it receives the Royal assent.

That *clauses 70 to 89*, and the *First Schedule*, be a separate Bill; and that for *clause 70* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Private Investigators and Security Guards Act 1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Private Investigators and Security Guards Amendment Act 1995, and shall be read together with and deemed part of the Private Investigators and Security Guards Act 1974 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1995.

That *clauses 90 and 91* be a separate Bill; and that for *clause 90* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Property Law Act 1952**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Property Law Amendment Act 1995, and shall be read together with and deemed part of the Property Law Act 1952 (hereinafter referred to as the principal Act).
