Clause 3: To insert on page 3, after subclause (1), the following subclause:

(1A) Section 32 of the principal Act (as substituted by section 4 of the Licensing Trusts Amendment Act 1962) is hereby amended by inserting in subsection (4) (as amended by section 12 of the Licensing Trusts Amendment Act 1976), after the words "section 28B of this Act", the words "or of any catering premises of a standard approved by the Commission under section 28c of this Act'

Clause 7: To insert on page 5, after subclause (1), the following subclause:

(1A) Section 73 of the principal Act (as inserted by section 9 of the Licensing Trusts Amendment Act 1976) is hereby amended by inserting, after subsection (1), the following subsection:

EXPLANATORY NOTE

Clause 3: The amendment makes it clear that there is no obligation to provide accommodation on catering premises conducted by a Trust. The amendments to clauses 9 and 13 make corresponding provisions in respect of the Masterton and Invercargill Licensing Trusts.

Clause 7: The amendment makes it clear that a Licensing Committee of a district adjoining a suburban Trust area has jurisdiction to hear and determine applications in respect of private licences operating in the Trust area.
