MARITIME AND AVIATION CRIMES BILL

Proposed Motion to Divide Bill into 4 Bills

Rt Hon DON MCKINNON, in Committee, to move the following motion:

That *Part 1* be a separate Bill, and that for the heading above *clause* 2 there be substituted the following Title, enacting words, and clause:

An Act to give effect to the provisions of the Rome Convention for the Suppression of Unlawful Acts Against the Safety of Maritime Navigation and the Rome Protocol for the Suppression of Unlawful Acts Against the Safety of Fixed Platforms Located on the Continental Shelf

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Maritime Crimes Act 1998.

(2) Except for section 15, this Act comes into force on the 28th day after the date on which this Act receives the Royal assent.

(3) Section 15 comes into force on a date to be appointed by the Governor-General by Order in Council.

That *Part 2* be a separate Bill, and that for *clause 22* and the heading above that clause there be substituted the following Title, enacting words, and clause:

An Act-

- (a) To amend the Aviation Crimes Act 1972 to give effect to the provisions of the Montreal Protocol for the Suppression of Unlawful Acts of Violence at Airports Serving International Civil Aviation; and
- (b) To give effect to further matters incidental to the Hague Convention for the Suppression of Unlawful Seizure of Aircraft and the Montreal Convention for the Suppression of Unlawful Acts Against the Safety of Civil Aviation

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Aviation Crimes Amendment Act 1998, and is part of the Aviation Crimes Act 1972 ("the principal Act").

(2) This Act comes into force on the 28th day after this Act receives the Royal assent.

That Part 3, Schedule 1, and Schedule 2 be a separate Bill, and that for *clause 34* and the heading above that clause there be substituted the following Title, enacting words, and clause:

An Act to amend the Extradition Act 1965

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Extradition Amendment Act 1998, and is part of the Extradition Act 1965 ("the principal Act").

(2) This Act comes into force on the 28th day after the date on which this Act receives the Royal assent.

That Part 4, Schedule 3, and Schedule 4 be a separate Bill, and that for clause 37 and the heading above that clause there be substituted the following Title, enacting words, and clause:

An Act to amend the Mutual Assistance in Criminal Matters Act 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Mutual Assistance in Criminal Matters Amendment Act 1998, and is part of the Mutual Assistance in Criminal Matters Act 1992 ("the principal Act").

(2) This Act comes into force on a date to be appointed by the Governor-General by Order in Council.

EXPLANATORY NOTE

The motion in this Supplementary Order Paper divides the Maritime and Aviation Crimes Bill into 4 Bills, namely,—

(1) The Maritime Crimes Bill

(2) The Aviation Crimes Amendment Bill

(3) The Extradition Amendment Bill

(4) The Mutual Assistance in Criminal Matters Amendment Bill.
