MAORI PURPOSES BILL

Proposed Motion to Divide the Bill into 5 Bills

Hon. JOHN LUXTON, in Committee, to move the following motion:

That *clauses 2 and 3* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

An Act to amend the Maori Affairs Restructuring Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Maori Affairs Restructuring Amendment Act 1996, and shall be read together with and deemed part of the Maori Affairs Restructuring Act 1989 (hereinafter referred to as the principal Act).

That *clauses 4 and 5* be a separate Bill, and that for *clause 4* there be substituted the following Title, enacting words, and clause:

An Act to amend the Maori Community Development Act 1962

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Maori Community Development Amendment Act 1996, and shall be read together with and deemed part of the Maori Community Development Act 1962 (hereinafter referred to as the principal Act).

That *clauses 6 to 9* be a separate Bill, and that for *clause 6* there be substituted the following Title, enacting words, and clause:

An Act to amend the Maori Trustee Act 1953

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Maori Trustee Amendment Act 1996, and shall be read together with and deemed part of the Maori Trustee Act 1953 (hereinafter referred to as the principal Act).

That *clauses 10 to 15* be a separate Bill, and that for *clause 10* there be substituted the following Title, enacting words, and clause:

An Act to amend the Te Ture Whenua Maori Act 1993 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—(1) This Act may be cited as—

(a) Te Ture Whenua Maori Amendment Act 1996; or

(b) The Maori Land Amendment Act 1996.

(2) This Act shall be read together with and deemed part of the Te Ture Whenua Maori Act 1993 (hereinafter referred to as the principal Act).

That clauses 16 to 22 be a separate Bill, and that for clause 16 there be substituted the following Title, enacting words, and clause:

An Act to amend the Maori Trust Boards Act 1955
BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Maori Trust Boards Amendment Act 1996, and shall be read together with and deemed part of the Maori Trust Boards Act 1955 (hereinafter referred to as the principal Act).
