### NATIVE LAND CLAIMS ADJUSTMENT BILL.

Mr. KAIHAU, in Committee, to move the following new clause :—

A. (1.) The Governor may by Order in Council vest in the Committee hereinafter mentioned the lands referred to in Parliamentary Paper G.-1B, 1909, the First and Second Schedule to Parliamentary Paper G.-10, 1909, Session II, being a report of proceedings of a conference held at Waahi in reference to the said lands.

(2.) The said Committee shall consist of six persons appointed by the Governor, of whom four shall be appointed on the recommendation of the owners of the said lands.

(3.) The said Committee shall have the administration and management of the lands vested in them as aforesaid, and shall deal with the same in manner recommended by the said report; and for that purpose the Committee shall have the same powers and duties as a Maori Land Board under Parts XIV. and XVI of the Native Act, 1909, save that section two hundred and thirty-nine of that Act shall not apply to the Committee.

(4.) The Governor may from time to time by Order in Council make regulations concerning the manner in which recommendations of persons to be appointed members of the Committee may from time to time be made, and the tenure of office of members of the Committee, and generally all matters relating to the setting-up and proceedings of the Committee.

(5.) No Order in Council affecting the said lands shall be made under section two hundred and thirty-four of the Native Land Act, 1909.

### [TRANSLATION.]

Mr. KAIHAU, i roto i te Komiti, ka motini i tenei Tekiona hou :—

A. (1.) Me whakataka e te Kawana i raro i tetahi Ota Kaunihera ki raro ki te Komiti a muri ake nei whakahuatia ai nga whenua e whakaaria ra i roto i Pepa Paremata G.-1B, 1909, nga Kupu Apiti Tuatahi, Tuarua o te Pepa Paremata G.-10, 1909, Tuunga Paremata Tuarua, ara he ripoata no nga mahi a te huihuinga i tu ki Waahi mo runga mo aua whenua.

(2.) Kia ono nga mema mo taua Komiti ma te Kawana ratou e whakatu a kia tokowha o ratou e whakatu i runga i te kupu tohutohu a nga tangata e whaipaanga ana ki aua whenua.

(3.) Me riro i taua Komiti te mana me te whakahaere o nga whenua i whakatakaina ki raro kia ratou e kiia ake ra a me whakahaere hoki i runga i nga kupu tohutohu o taua ripoata, a hei mea e tutuki ai tera whakaaro me riro i te Komiti nga mana pera me o te Poari Whenua Maori i raro i Wahi XIV me XVI o te Ture Whenua Maori, 1909, engari ia kaua te tekiona 239 o taua Ture e pa ki taua Komiti.

(4.) Ka ahei te Kawana me Ota Kaunihera ia wa ia wa kite hanga rekureihana e pa ana mo te ahua o nga kupu tohutohu e pa ana ki nga tangata hei whakatuunga hei mema mo te Komiti me te roa o te wa hei tuunga mo ia mema o te Komiti me era atu take hoki e pa ana ki te whakatuunga me te whakahaere a te Komiti.

(5.) Kaua me mahia tetahi Ota Kaunihera mo runga mo enei whenua i raro i tekiona 234 o te Ture Whenua Maori, 1909.
