Proposed amendments

Rod Donald, in committee, to move the following amendments:

Part 1:

*Clause 3(1):* 

To insert after, the words "internationally competitive", the words ", ecologically and socially sustainable"

#### New clause 3A:

To insert, after clause 3, the following clause:

#### **3A** Sustainability principles

In achieving the purpose of this Act, all persons exercising responsibilities, powers, or functions under it must take into account—

- (a) the health and safety of people and communities, and their social, economic, and cultural well-being; and
- (b) the need to maintain and enhance the quality of the environment; and
- (c) the reasonably foreseeable needs of future generations; and
- (d) the principles of the Treaty of Waitangi.

#### Part 2:

Clause 9(1)(a):

To omit the word "economic" (in line 25 on page 6).

Clause 9(1)(a)(i):

To insert, after the words "trade unions" (line 3 on page 7), the words ", the community economic sector".

To insert, after the word "regions" (line 10 on page 7), the words ", local communities".

#### *Clause* 9(1):

To insert, after clause 9(1)(d), the following paragraphs:

- (da) contribute to increased import substitution within, and investment in, New Zealand by—
  - (i) strengthening domestic linkages through trade and investment promotion; and
  - (ii) providing appropriate business and market development assistance:
- (db) co-operate with Tourism New Zealand where appropriate in order to achieve coordinated sustainable development:
- (dc) ensure that before funds are allocated to any organisation, the organisation meets the good employer criteria set out in **section 31(2)**:

#### Clause 19:

To add, after subclause (2)(b), the following paragraphs:

- (c) the chief executive of the Ministry for the Environment; and
- (d) the chief executive of the Ministry of Social Development; and
- (e) the chief executive of Te Puni Kokiri.

#### *Clause 31(2)*

To add the following paragraph:

(i) recognition of equal pay for work of equal value.

#### Clause 54(a):

To insert, after the word "commitments" (line 17 on page 21), the words "to achieving sustainable development".

#### Clause 56(1)(c)(v):

To insert, after the words "other measures" (line 22 on page 22), the words ", including economic, environmental, social, and cultural indicators of sustainability,".

#### *Clause* 66(1):

To insert, after paragraph (c), the following paragraph:

(ca) a statement of sustainability performance covering economic, environmental, social, and cultural outcomes:
