Third Schedule: To omit from subsection (1) of the proposed new 13AA of the Industrial and Provident Societies Act 1908 on page 29 the words "in the course", and substitute the words "as a result".

To omit from subsection (1) of the proposed new section 9AA of the Companies Act 1955 on page 32 the words "in the course", and substitute the words "as a result".

To insert on page 32, as subsection (3) of the proposed new section 9AA of the Companies Act 1955, the following subsection:

"(3) In this section, 'company' includes an overseas company."

To omit from page 35 the item relating to the Reserve Bank of New Zealand Act 1964.

To omit from page 40 the item relating to the Tobacco Growing Industry Act 1974.

To omit from subsection (1) of the proposed new section 67A of the Securities Act 1978 on page 45 the words "in the course", and substitute the words "as a result".

Fourth Schedule: To omit the item on page 50 relating to the Wage Freeze Regulations 1982.

EXPLANATORY NOTE

This Supplementary Order Paper makes a number of amendments to the Official Information Amendment Bill. They are as follows:

(a) *Clause 20* is amended—

(i) By adding a provision to repeal the amendment to the principal Act contained in the Third Schedule to the State-Owned Enterprises Act 1986. That repeal is consequential upon the inclusion of the new state enterprises in the new First Schedule to the principal Act, as substituted by the *Second Schedule* to the Bill (see (b) (vi) below):

(ii) By adding section 27 of the Environment Act 1986 to the list of provisions repealed by that clause. That repeal is consequential upon the inclusion of the Parliamentary Commissioner for the Environment in the

- new First Schedule to the principal Act, as substituted by the *Second Schedule* to the Bill (see (b) (iii) below):
- (b) The *Second Schedule* to the Bill is amended—
- (i) By reinstating a reference to the New Zealand Potato Board, which through a printing error was omitted from the Bill as reported back from the Select Committee:
 - (ii) By deleting the reference to the New Zealand Survey Board, included through a printing error in the Bill as reported back from the Select Committee:
 - (iii) By adding a reference to the Parliamentary Commissioner for the Environment:
 - (iv) By updating the reference to the Survey Board to the Survey Board of New Zealand:
 - (v) By deleting the reference to the Tobacco Board, which is to be dissolved:
 - (vi) By adding references to the new state enterprises listed in the Second Schedule to the State-Owned Enterprises Act 1986:
- (c) The *Third Schedule* to the Bill is amended—
- (i) By adding a new subsection (3) to the proposed new section 9AA of the Companies Act 1955. In the new section the term “company” is to include an overseas company:
 - (ii) By deleting the amendment to section 31 of the Reserve Bank of New Zealand Act 1964. That section will be repealed by section 10 (1) of the Reserve Bank of New Zealand Amendment Act 1986, which comes into force on 1 April 1987:
 - (iii) By deleting the amendment to the Tobacco Growing Industry Act 1974, which is to be repealed:
 - (iv) By making a minor technical drafting amendment to the amendments to the Industrial and Provident Societies Act 1908, the Companies Act 1955, and the Securities Act 1978:
- (d) The *Fourth Schedule* to the Bill is amended by omitting the amendment relating to the Wage Freeze Regulations 1982, which have now been revoked.
