PRIVACY BILL

Proposed Motion to Divide Bill into 10 Separate Bills

Hon. D. A. M. GRAHAM, in Committee, to move as follows:

That *Parts I to XII* and the *Schedules* be a separate Bill with the following Title, enacting words, and Short Title clause:

An Act to promote and protect individual privacy in general accordance with the Recommendation of the Council of the Organisation for Economic Co-operation and Development Concerning Guidelines Governing the Protection of Privacy and Transborder Flows of Personal Data, and, in particular,—

- (a) To establish certain principles with respect to—
- (i) The collection, use, and disclosure, by public and private sector agencies, of information relating to individuals; and
 - (ii) Access by each individual to information relating to that individual and held by public and private sector agencies; and
- (b) To provide for the appointment of a Privacy Commissioner to investigate complaints about interferences with individual privacy; and
- (c) To provide for matters incidental thereto

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Privacy Act 1993.

(2) Except as provided by section 30 (2) of this Act, this Act shall come into force on the 1st day of July 1993.

That *clauses 128 to 129B* be a separate Bill, and that for *clause 128* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Births and Deaths Registration Act 1951

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Births and Deaths Registration Amendment Act (No. 2) 1993, and shall be read together with and deemed part

of the Births and Deaths Registration Act 1951 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 130 and 131* be a separate Bill, and that for *clause 130* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Penal Institutions Act 1954

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Penal Institutions Amendment Act (No. 2) 1993, and shall be read together with and deemed part of the Penal Institutions Act 1954.

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 132 to 133A* be a separate Bill, and that for *clause 132* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Marriage Act 1955

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Marriage Amendment Act (No. 2) 1993, and shall be read together with and deemed part of the Marriage Act 1955 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 133B to 133D* be a separate Bill, and that for *clause 133B* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Health Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Health Amendment Act (No. 2) 1993, and shall be read together with and deemed part of the Health Act 1956 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 133E to 133G* be a separate Bill, and that for *clause 133E* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Crimes Act 1961

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Crimes Amendment Act (No. 3) 1993, and shall be read together with and deemed part of the Crimes Act 1961 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 139A to 139E* be a separate Bill, and that for *clause 139A* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Ombudsmen Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Ombudsmen Amendment Act (No. 2) 1993, and shall be read together with and deemed part of the Ombudsmen Act 1975 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 140 to 148* be a separate Bill, and that for *clause 140* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Human Rights Commission Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Human Rights Commission Amendment Act (No. 3) 1993, and shall be read together with and deemed part of the Human Rights Commission Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 149 to 158* be a separate Bill, and that for *clause 149* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Official Information Act 1982

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Official Information Amendment Act 1993, and shall be read together with and deemed part of the Official Information Act 1982 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

That *clauses 163 to 169* be a separate Bill, and that for *clause 163* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Local Government Official Information and Meetings Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Local Government Official Information and Meetings Amendment Act (No. 3) 1993, and shall be read together with and deemed part of the Local Government Official Information and Meetings Act 1987 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1993.

EXPLANATORY NOTE

This Supplementary Order Paper contains the appropriate motion to divide the Privacy Bill into 10 separate Bills—the Privacy Bill, the Births and Deaths Registration Amendment Bill (No. 2), the Penal Institutions Amendment Bill (No. 2), the Marriage Amendment Bill (No. 2), the Health Amendment Bill (No. 2), the Crimes Amendment Bill (No. 3), the Ombudsmen Amendment Bill (No. 2), the Human Rights Commission Amendment Bill (No. 3), the Official Information Amendment Bill, and the Local Government Official Information and Meetings Amendment Bill (No. 3).
