PATRIOTIC AND CANTEEN FUNDS AMENDMENT

Proposed Amendments

This Supplementary Order Paper is in substitution for Supplementary Order Paper No. 63.

Hon. PETER TAPSELL, in Committee, to move the following amendments:

Clause 1: To insert in line 12 on page 1, before the words "This Act", the words "Except as provided in section 7 (5) of this Act,".

Clause 5: To omit from line 12 on page 4 the expression "1985", and substitute the expression "1986".

Clause 7: To add, after clause 6 on page 8, the following clause:

7. Transitional provisions—(1) Notwithstanding anything in this Act or the principal Act—

- (a) The financial year in respect of each of the New Zealand Patriotic Fund Board and the Canteen Funds Board that would otherwise end on the 30th day of September 1985 shall end on the 31st day of December 1985:
- (b) The report of each of those Boards that would otherwise be furnished to the Minister not later than the 31st day of December 1985 shall be furnished not later than the 31st day of March 1986:
- (c) The first financial year in respect of the Patriotic and Canteen Funds Board shall commence on the 1st day of January 1986 and end with the 30th day of September 1986.

(2) The officers appointed by the New Zealand Patriotic Fund Board pursuant to section 8 of the principal Act (as in force before the commencement of this Act) and by the Canteen Fund Board pursuant to section 30 of the principal Act (as so in force) are hereby deemed to have been appointed by the New Zealand Patriotic and Canteen Funds Board as officers of that Board pursuant to section 8 of the principal Act (as substituted by section 3 of this Act).

(3) All committees appointed by the New Zealand Patriotic Fund Board pursuant to section 7 (c) of the principal Act (as in force before the commencement of this Act) and all

committees appointed by the Canteen Fund Board pursuant to section 29 (b) of the principal Act (as so in force) are hereby deemed to have been appointed by the New Zealand Patriotic and Canteen Funds Board as committees of that Board pursuant to section 7 (c) of the principal Act (as substituted by **section 3** of this Act), and all powers delegated to such committees by the New Zealand Patriotic Fund Board pursuant to the said section 7 (c) (as so in force) and by the Canteen Fund Board pursuant to the said section 29 (b) (as so in force) shall, so far as they are applicable, be deemed to have been delegated by the New Zealand Patriotic and Canteen Funds Board pursuant to the said section 7 (c) (as so substituted).

(4) The Chairman and Deputy Chairman of the New Zealand Patriotic Fund Board appointed pursuant to section 5 of the principal Act (as in force before the commencement of this Act) shall be deemed to be the Chairman and Deputy Chairman of the New Zealand Patriotic and Canteen Funds Board until such time as that Board appoints a Chairman and Deputy Chairman pursuant to section 5 of the principal Act (as substituted by **section 3** of this Act).

(5) **Subsection (1)** of this section shall be deemed to have come into force on the 1st day of October 1985.

EXPLANATORY NOTE

Clause 1: This amendment is consequential on *clause 7 (2)*.

Clause 5: This amendment is consequential on the change in the date of commencement of the Bill.

Clause 7 provides for transitional provisions on the amalgamation of the New Zealand Patriotic Fund Board and the Canteen Funds Board into the Patriotic and Canteen Funds Board.

Subclauses (1) and (5) provide that—

- (a) The last financial year in respect of each of the 2 old Boards is extended from 30 September 1985 to 31 December 1985;
- (b) The last report of each of those Boards is now to be furnished to the Minister not later than 31 March 1986;
- (c) The first financial year in respect of the new Board is to be the period of 9 months ending with 30 September 1986.

Subclause (2) provides that the officers appointed by each of the 2 old Boards are deemed to have been appointed by the new Board.

Subclause (3) provides that all committees appointed by each of the 2 old Boards are deemed to have been appointed by the new Board.

Subclause (4) provides that the Chairman and Deputy Chairman of the old New Zealand Patriotic Fund Board shall be deemed to be the Chairman and Deputy Chairman of the new Board until such time as appointments are made by the new Board.
