Proposed amendments

Hon Margaret Wilson, in Committee, to move the following amendments:

Preamble

To insert in line 3 on page 3, after the word "a", the word "Te".

To omit from line 35 on page 3 the word "tino", and substitute the word "timo".

To omit from line 11 on page 4 the word "e" in the second place where it appears, and substitute the word "te".

To insert in line 21 on page 4, before the word "tua", the word "i".

To insert in line 27 on page 5, after the word "i", the words "a ia".

Clause 6

To insert in line 11 on page 9, after the word "to", the word "ratou".

Clause 9

To insert in the definition of **deed of settlement**, after the word "of" (line 34 on page 11), the word "the".

To omit from the definition of **Pouakani Block** (lines 17 and 18 on page 12) the words "Registry, the boundaries of which are shown as S.O. Plan **0000**", and substitute the word "District".

Clause 12(3)

To insert, after the words "of law," (line 3 on page 15), the words "on and from the settlement date,".

Clause 14

To omit from subclause (1)(a) the word "Registry" (line 8 on page 16), and substitute the words "Land District".

To omit from subclause (1)(b) the words "comprised in the Pouakani Block" (line 9 on page 16), and substitute the words "described in S.O. Plan **61526**". To omit from subclause (3) the words "that part of the land described as **0000** in S.O. Plan **000**" (lines 20 and 21 on page 16), and substitute the words "the land described in ML Plan 14984".

To add to the heading to this clause the word "people".

Clause 23

To omit from the heading to this clause the word "Covenants", and substitute the word "Covenant".

Clause 28(5)

To omit from line 20 on page 22 the word "Registry", and substitute the words "Land District".
