PUBLIC SERVICE CLASSIFICATION AND SUPERANNUATION AMENDMENT BILL.

Right Hon. Sir J. G. WARD, in Committee, to move the following amendments:-

Clause 15: Insert, after the word "fund" in line 33, the words "less any sums already received by him from the fund."

Clause 18: Insert, after the word "fund" in line 53, the words "less any sums already received by him from the fund."

Add the following new clause:—

definition of "Education service.

- 26A. (1.) Every person who at the passing of this Act is perprovisions for manently employed in the Education service as defined by this Act, but whose employment is not included in the Education service as defined by the principal Act, may within three months after the passing of this Act, by notice in writing delivered to the Secretary of the Board or to the Minister of Education, elect to become a contributor to the fund.
 - (2.) If any person so electing is already a contributor to the Public Service Superannuation Fund he shall thereupon cease to be a contributor thereto, and the amount of his contributions thereto shall be transferred from that fund to the Teachers' Superannuation Fund, and shall be computed as contributions made by him under this Part of this Act.
 - (3.) Every person so electing shall contribute to the Teachers' Superannuation Fund at a rate determined by his age at the date of his election.
 - (4.) In the case of every person so electing, the length of his service shall for the purposes of this Act be deemed to be the aggregate of the following periods:

(a.) The period during which he has been a contributor to

the Teachers' Superannuation Fund;

(b.) The period during which, before becoming a contributor to that fund, he has been in the Education service as defined by this Act. whether continuously or not.

Clause 58: Insert, after the word "fund" in line 40, the words "less any sums already received by him from the fund."

Clause 64 (2): Insert, after the word "salary" in line 20, the words

" or allowance."

Clause 64 (3): Insert, after the word "salary" in line 23, the words "or allowance."

Add the following new clause:

Section 28 of 64A. (1.) The provisions of section twenty-eight of the Civil Serthe Civil Service Act, 1908, other than the provisions contained in paragraph (d) to apply to grant thereof, shall not apply to the grant of a pension or annual superannuation or retiring allowance to any person entitled thereto under pensions. the Civil Service Superannuation Act, 1858, or the Civil Service Act, 1866.

(2.) When any such pension or allowance is granted to any person in pursuance of either of those Acts, a statement thereof shall be laid by the Minister of Finance before Parliament within ten days thereafter if Parliament is then sitting, or if not, then within ten days after the commencement of the next ensuing session.
