RESOURCE MANAGEMENT AMENDMENT BILL

Proposed Motion to Divide Bill into 17 Bills

Hon. W. ROB STOREY, in Committee, to move as follows:

That *clause 1, Parts I to XIII, clauses 187 to 205, 207, 208, 208A, and 208B*, and the First and Second Schedules be a separate Bill, and that for *clause 1* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Resource Management Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Resource Management Amendment Act 1993, and shall be read together with and deemed part of the Resource Management Act 1991 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 208c and 208d* be a separate Bill, and that for *clause 208c* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Harbours Act 1950

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Harbours Amendment Act 1993, and shall be read together with and deemed part of the Harbours Act 1950 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 208E, 209, 210, and 210A* be a separate Bill, and that for *clause 208E* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Maori Land Act 1993

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Maori Land Amendment Act 1993, and shall be read together with and deemed part of the Maori Land Act 1993 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 210B, 210c, and 211* be a separate Bill, and that for *clause 210B* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Health Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Health Amendment Act (No. 3) 1993, and shall be read together with and deemed part of the Health Act 1956 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 211A and 211B* be a separate Bill, and that for *clause 211A* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Airport Authorities Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Airport Authorities Amendment Act 1993, and shall be read together with and deemed part of the Airport Authorities Act 1966 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 211c and 211D* be a separate Bill, and that for *clause 211c* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Local Government Act 1974

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Local Government Amendment Act (No. 8) 1993, and shall be read together with and deemed part of the Local Government Act 1974 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 30th day of June 1993.

That *clauses 211E, and 212 to 214* be a separate Bill, and that for *clause 211E* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Unit Titles Amendment Act 1979

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Unit Titles Amendment Act 1993, and shall be read together with and deemed part of the Unit Titles Amendment Act 1979.

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 214A and 215* be a separate Bill, and that for *clause 214A* there be substituted the following Title, enacting words, and short Title clause:

An Act to amend the Reserves Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Reserves Amendment Act (No. 3) 1993, and shall be read together with and deemed part of the Reserves Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 215A and 216* be a separate Bill, and that for *clause 215A* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Forestry Rights Registration Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Forestry Rights Registration Amendment Act 1993, and shall be read together with and deemed part of the Forestry Rights Registration Act 1983 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 216A and 216B* be a separate Bill, and that for *clause 216A* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Port Companies Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Port Companies Amendment Act 1993, and shall be read together with and deemed part of the Port Companies Act 1988 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 216c and 217* be a separate Bill, and that for *clause 216c* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Education Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Education Amendment Act (No. 7) 1993, and shall be read together with and deemed part of the Education Act 1989 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 217A and 218* be a separate Bill, and that for *clause 217A* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Crown Forest Assets Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Crown Forest Assets Amendment Act (No. 2) 1993, and shall be read together with and deemed part of the Crown Forest Assets Act 1989 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 218A, 219, and 219A* be a separate Bill, and that for *clause 218A* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the New Zealand Railways Corporation Restructuring Act 1990

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the New Zealand Railways Corporation Restructuring Amendment Act 1993, and shall be read together with and deemed part of the New Zealand Railways Corporation Restructuring Act 1990 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 219B, 219C, and 219D* be a separate Bill, and that for *clause 219B* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Sugar Loaf Islands Marine Protected Area Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Sugar Loaf Islands Marine Protected Area Amendment Act 1993, and shall be read together with and deemed part of the Sugar Loaf Islands Marine Protected Area Act 1991 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 219E and 219F* be a separate Bill, and that for *clause 219E* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Historic Places Act 1993

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Historic Places Amendment Act 1993, and shall be read together with and deemed part of the Historic Places Act 1993 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 220 to 223* be a separate Bill, and that for *clause 220* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Marine Farming Act 1971

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Marine Farming Amendment Act (No. 2) 1993, and shall be read together with and deemed part of the Marine Farming Act 1971 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *clauses 224 to 234* be a separate Bill, and that for *clause 224* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Fisheries Act 1983

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Fisheries Amendment Act (No. 5) 1993, and shall be read together with and deemed part of the Fisheries Act 1983 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.
