STATUTES AMENDMENT BILL

*Proposed Amendments*

Hon. Mr HANAN, in Committee, to move the following amendments:

*Agricultural Chemicals*

That *clauses 2 to 4* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Agricultural Chemicals Act 1959**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Agricultural Chemicals Amendment Act 1963, and shall be read together with and deemed part of the Agricultural Chemicals Act 1959 (hereinafter referred to as the principal Act).

*Auckland Harbour Bridge*

That *clauses 5 and 6* be a separate Bill, and that for *clause 5* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Auckland Harbour Bridge Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Auckland Harbour Bridge Amendment Act 1963, and shall be read together with and deemed part of the Auckland Harbour Bridge Act 1950 (hereinafter referred to as the principal Act).

*Bills of Exchange*

That *clauses 7 and 8* be a separate Bill, and that for *clause 7* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Bills of Exchange Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Bills of Exchange Amendment Act 1963, and shall be read together with and deemed part of the Bills of Exchange Act 1908 (hereinafter referred to as the principal Act).

*Births and Deaths Registration*

That *clauses 9 to 11* be a separate Bill, and that for *clause 9* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Births and Deaths Registration Act 1951**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Births and Deaths Registration Amendment Act 1963, and shall be read together with and deemed part of the Births and Deaths Registration Act 1951 (hereinafter referred to as the principal Act).

*Chatham Islands County Council Empowering*

That *clauses 12 and 13* be a separate Bill, and that for *clause 12* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Chatham Islands County Council Empowering Act 1936**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Chatham Islands County Council Empowering Amendment Act 1963, and shall be read together with and deemed part of the Chatham Islands County Council Empowering Act 1936.

*Chattels Transfer*

That *clauses 14 and 15* be a separate Bill, and that for *clause 14* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Chattels Transfer Act 1924**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Chattels Transfer Amendment Act 1963, and shall be read together with and deemed part of the Chattels Transfer Act 1924 (hereinafter referred to as the principal Act).

*Civil Aviation*

That *clauses 16 and 17* be a separate Bill, and that for *clause 16* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Civil Aviation Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Civil Aviation Amendment Act 1963, and shall be read together with and deemed part of the Civil Aviation Act 1948 (hereinafter referred to as the principal Act).

*Clerks of Works*

That *clauses 18 to 20* be a separate Bill, and that for *clause 18* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Clerks of Works Act 1944**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Clerks of Works Amendment Act 1963, and shall be read together with and deemed part of the Clerks of Works Act 1944 (hereinafter referred to as the principal Act).

*Cooperative Dairy Companies*

That *clauses 21 and 22* be a separate Bill, and that for *clause 21* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Cooperative Dairy Companies Act 1949**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Cooperative Dairy Companies Amendment Act 1963, and shall be read together with and deemed part of the Cooperative Dairy Companies Act 1949 (hereinafter referred to as the principal Act).

*Counties*

That *clauses 23 and 24* be a separate Bill, and that for *clause 23* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Counties Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Counties Amendment Act 1963, and shall be read together with and deemed part of the Counties Act 1956 (hereinafter referred to as the principal Act).

*Dangerous Drugs*

That *clauses 25 and 26* be a separate Bill, and that for *clause 25* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Dangerous Drugs Act 1927**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Dangerous Drugs Amendment Act 1963, and shall be read together with and deemed part of the Dangerous Drugs Act 1927 (hereinafter referred to as the principal Act).

*Dangerous Goods*

That *clauses 27 to 29* be a separate Bill, and that for *clause 27* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Dangerous Goods Act 1957**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Dangerous Goods Amendment Act 1963, and shall be read together with and deemed part of the Dangerous Goods Act 1957 (hereinafter referred to as the principal Act).

*Electoral*

That *clauses 30 and 31* be a separate Bill, and that for *clause 30* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Electoral Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Electoral Amendment Act 1963, and shall be read together with and deemed part of the Electoral Act 1956 (hereinafter referred to as the principal Act).

*Electricians*

That *clauses 32 and 33* be a separate Bill, and that for *clause 32* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Electricians Act 1952**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Electricians Amendment Act 1963, and shall be read together with and deemed part of the Electricians Act 1952 (hereinafter referred to as the principal Act).

*Evidence*

That *clauses 34 and 35* be a separate Bill, and that for *clause 34* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Evidence Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Evidence Amendment Act 1963, and shall be read together with and deemed part of the Evidence Act 1908.

*Exhibitions*

That *clauses 36 to 39* be a separate Bill, and that for *clause 36* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Exhibitions Act 1910**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Exhibitions Amendment Act 1963, and shall be read together with and deemed part of the Exhibitions Act 1910 (hereinafter referred to as the principal Act).

*Friendly Societies*

That *clauses 39 and 40* be a separate Bill, and that for *clause 39* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Friendly Societies Act 1909**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Friendly Societies Amendment Act 1963, and shall be read together with and deemed part of the Friendly Societies Act 1909 (hereinafter referred to as the principal Act).

*Harbours*

That *clauses 41 to 43* be a separate Bill, and that for *clause 41* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Harbours Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Harbours Amendment Act 1963, and shall be read together with and deemed part of the Harbours Act 1950 (hereinafter referred to as the principal Act).

*Impounding*

That *clauses 44 to 46* be a separate Bill, and that for *clause 44* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Impounding Act 1955**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Impounding Amendment Act 1963, and shall be read together with and deemed part of the Impounding Act 1955 (hereinafter referred to as the principal Act).

*Infants*

That *clauses 47 and 48* be a separate Bill, and that for *clause 47* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Infants Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Infants Amendment Act 1963, and shall be read together with and deemed part of the Infants Act 1908 (hereinafter referred to as the principal Act).

*Land*

That *clauses 49 to 51* be a separate Bill, and that for *clause 49* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Land Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Land Amendment Act 1963, and shall be read together with and deemed part of the Land Act 1948 (hereinafter referred to as the principal Act).

*Land Settlement Promotion*

That *clauses 52 to 54* be a separate Bill, and that for *clause 52* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Land Settlement Promotion Act 1952**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Land Settlement Promotion Amendment Act 1963, and shall be read together with and deemed part of the Land Settlement Promotion Act 1952 (hereinafter referred to as the principal Act).

*Law Practitioners*

That *clauses 55 and 56* be a separate Bill, and that for *clause 55* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Law Practitioners Act 1955**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Law Practitioners Amendment Act 1963, and shall be read together with and deemed part of the Law Practitioners Act 1955 (hereinafter referred to as the principal Act).

*Limitation*

That *clauses 57 and 58* be a separate Bill, and that for *clause 57* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Limitation Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Limitation Amendment Act 1963, and shall be read together with and deemed part of the Limitation Act 1950 (hereinafter referred to as the principal Act).

*Local Authorities Loans*

That *clauses 59 and 60* be a separate Bill, and that for *clause 59* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Local Authorities Loans Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Local Authorities Loans Amendment Act 1963, and shall be read together with and deemed part of the Local Authorities Loans Act 1956 (hereinafter referred to as the principal Act).

*Local Authorities (Members' Contracts)*

That *clauses 61 and 62* be a separate Bill, and that for *clause 61* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Local Authorities (Members' Contracts) Act 1954**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Local Authorities (Members' Contracts) Amendment Act 1963, and shall be read together with and deemed part of the Local Authorities (Members' Contracts) Act 1954 (hereinafter referred to as the principal Act).

*Local Elections and Polls*

That *clauses 63 and 64* be a separate Bill, and that for *clause 63* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Local Elections and Polls Act 1953**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Local Elections and Polls Amendment Act 1963, and shall be read together with and deemed part of the Local Elections and Polls Act 1953 (hereinafter referred to as the principal Act).

*Magistrates' Courts*

That *clauses 65 to 67* be a separate Bill, and that for *clause 65* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Magistrates' Courts Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Magistrates' Courts Amendment Act 1963, and shall be read together with and deemed part of the Magistrates' Courts Act 1948 (hereinafter referred to as the principal Act).

*Maori Education Foundation*

That *clauses 68 and 69* be a separate Bill, and that for *clause 68* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Maori Education Foundation Act 1961**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Maori Education Foundation Amendment Act 1963, and shall be read together with and deemed part of the Maori Education Foundation Act 1961 (hereinafter referred to as the principal Act).

*Municipal Corporations*

*National Expenditure Adjustment*

**An Act to amend the National Expenditure Adjustment Act 1932**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the National Expenditure Adjustment Amendment Act 1963, and shall be read together with and deemed part of the National Expenditure Adjustment Act 1932 (hereinafter referred to as the principal Act).

*New Zealand Army*

**An Act to amend the New Zealand Army Act 1950**

1. **Short Title**—This Act may be cited as the New Zealand Army Amendment Act 1963, and shall be read together with and deemed part of the New Zealand Army Act 1950 (hereinafter referred to as the principal Act).

*Oaths and Declarations*

**An Act to amend the Post Office Act 1959**

*Primary Products Marketing*

*Public Bodies Meetings*

That *clauses 86 and 87* be a separate Bill, and that for *clause 86* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Public Bodies Meetings Act 1962**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Public Bodies Meetings Amendment Act 1963, and shall be read together with and deemed part of the Public Bodies Meetings Act 1962 (hereinafter referred to as the principal Act).

*Rangiora High School*

**An Act to amend the Rangiora High School Act 1881**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Rangiora High School Amendment Act 1963, and shall be read together with and deemed part of the Rangiora High School Act 1881 (hereinafter referred to as the principal Act).

*Rehabilitation*

That *clauses 90 and 91* be a separate Bill, and that for *clause 90* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Rehabilitation Act 1941**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Rehabilitation Amendment Act 1963, and shall be read together with and deemed part of the Rehabilitation Act 1941 (hereinafter referred to as the principal Act).

*Reserves and Domains*

That *clauses 92 and 93* be a separate Bill, and that for *clause 92* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Reserves and Domains Act 1953**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Reserves and Domains Amendment Act 1963, and shall be read together with and deemed part of the Reserves and Domains Act 1953 (hereinafter referred to as the principal Act).

*Royal New Zealand Air Force*

That *clauses 94 and 95* be a separate Bill, and that for *clause 94* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Royal New Zealand Air Force Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Royal New Zealand Air Force Amendment Act 1963, and shall be read together with and deemed part of the Royal New Zealand Air Force Act 1950 (hereinafter referred to as the principal Act).

*Sale of Liquor*

That *clauses 96 to 98* be a separate Bill, and that for *clause 96* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Sale of Liquor Act 1962**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Sale of Liquor Amendment Act 1963, and shall be read together with and deemed part of the Sale of Liquor Act 1962 (hereinafter referred to as the principal Act).

*Stamp Duties*

That *clauses 99 and 100* be a separate Bill, and that for *clause 99* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Stamp Duties Act 1954**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Stamp Duties Amendment Act 1963, and shall be read together with and deemed part of the Stamp Duties Act 1954 (hereinafter referred to as the principal Act).

*Stock Remedies*

That *clauses 101 and 102* be a separate Bill, and that for *clause 101* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Stock Remedies Act 1934**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Stock Remedies Amendment Act 1963, and shall be read together with and deemed part of the Stock Remedies Act 1934 (hereinafter referred to as the principal Act).

*Summary Proceedings*

That *clauses 103 to 105* be a separate Bill, and that for *clause 103* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Summary Proceedings Act 1957**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Summary Proceedings Amendment Act 1963, and shall be read together with and deemed part of the Summary Proceedings Act 1957 (hereinafter referred to as the principal Act).

*Termites*

That *clauses 106 and 107* be a separate Bill, and that for *clause 106* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Termites Act 1940**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Termites Amendment Act 1963, and shall be read together with and deemed part of the Termites Act 1940 (hereinafter referred to as the principal Act).
