Proposed Amendments

Right Hon. Mr Marshall, in Committee, to move the following amendments:

That clauses 4 to 6 be a separate Bill, and that for clause 4 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Births and Deaths Registration Act 1951

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Births and Deaths Registration Amendment Act 1969, and shall be read together with and deemed part of the Births and Deaths Registration Act 1951 (hereinafter referred to as the principal Act).

That clauses 7 and 8 be a separate Bill, and that for clause 7 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Boilers, Lifts, and Cranes Act 1950

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Boilers, Lifts, and Cranes Amendment Act (No. 2) 1969, and shall be read together with and deemed part of the Boilers, Lifts, and Cranes Act 1950 (hereinafter referred to as the principal Act).

That clauses 9 and 10 be a separate Bill, and that for clause 9 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the British Nationality and New Zealand Citizenship Act 1948

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the British Nationality and New Zealand Citizenship Amendment Act 1969, and shall be read together with and deemed part of the British Nationality and New Zealand Citizenship Act 1948 (hereinafter referred to as the principal Act).

That clauses 11 to 13 be a separate Bill, and that for clause 11 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Chattels Transfer Act 1924

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Chattels Transfer Amendment Act 1969, and shall be read together with and deemed part of the Chattels Transfer Act 1924 (hereinafter referred to as the principal Act).

That clauses 14 to 16 be a separate Bill, and that for clause 14 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Consumer Council Act 1966

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Consumer Council Amendment Act 1969, and shall be read together with and deemed part of the Consumer Council Act 1966 (hereinafter referred to as the principal Act).

That clauses 17 to 19 be a separate Bill, and that for clause 17 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Crimes Act 1961

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Crimes Amendment Act 1969, and shall be read together with and deemed part of the Crimes Act 1961 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of April

1970.

That clauses 20 and 21 be a separate Bill, and that for clause 20 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Crown Proceedings Act 1950

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Crown Proceedings Amendment Act 1969, and shall be read together with and deemed part of the Crown Proceedings Act 1950 (hereinafter referred to as the principal Act).

That clauses 22 and 23 be a separate Bill, and that for clause 22 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Dairy Board Act 1961

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Dairy Board Amendment Act 1969, and shall be read together with and deemed part of the Dairy Board Act 1961 (hereinafter referred to as the principal Act).

That clauses 24 to 27 and the Schedule be a separate Bill, and that for clause 24 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Extradition Act 1965

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Extradition Amendment Act 1969, and shall be read together with and deemed part of the Extradition Act 1965 (hereinafter referred to as the principal Act).

An Act to amend the Factories Act 1946

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Factories Amendment Act 1969, and shall be read together with and deemed part of the Factories Act 1946 (hereinafter referred to as the principal Act).

That clauses 30 and 31 be a separate Bill, and that for clause 30 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the External Affairs Act 1943

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Foreign Affairs Amendment Act 1969, and shall be read together with and deemed part of the Act heretofore known as the External Affairs Act 1943 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of March

1970.

That clauses 32 and 33 be a separate Bill, and that for clause 32 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Geothermal Energy Act 1953

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Geothermal Energy Amendment Act 1969, and shall be read together with and deemed part of the Geothermal Energy Act 1953 (hereinafter referred to as the principal Act).

An Act to amend the Guardianship Act 1968
