## STATUTES AMENDMENT BILL

*Proposed Amendments*

Hon. Mr THOMSON, in Committee, to move the following amendments:

That clauses 2 and 3 be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and Short Title:

## An Act to amend the Air Services Licensing Act 1951

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Air Services Licensing Amendment Act 1978, and shall be read together with an deemed part of the Air Services Licensing Act 1951 (hereinafter referred to as the principal Act).

That clauses 4 to 6 be a separate Bill, and that for clause 4 there be substituted the following Title, enacting words, and Short Title:

## An Act to amend the Apiaries Act 1969

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Apiaries Amendment Act 1978, and shall be read together with and deemed part of the Apiaries Act 1969 (hereinafter referred to as the principal Act).

That clauses 7 and 8 be a separate Bill, and that for clause 7 there be substituted the following Title, enacting words, and Short Title:

## An Act to amend the Building Societies Act 1965

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Building Societies Amendment Act 1978, and shall be read together with and deemed part of the Building Societies Act 1965 (hereinafter referred to as the principal Act).

That clauses 9 to 11 be a separate Bill, and that for clause 9 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Bush Workers Act 1945**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Bush Workers Amendment Act 1978, and shall be read together with and deemed part of the Bush Workers Act 1945 (hereinafter referred to as the principal Act).

That clauses 12 to 14 be a separate Bill, and that for clause 12 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Construction Act 1959**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Construction Amendment Act 1978, and shall be read together with and deemed part of the Construction Act 1959 (hereinafter referred to as the principal Act).

That clauses 15 and 16 be a separate Bill, and that for clause 15 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Domestic Proceedings Act 1968**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Domestic Proceedings Amendment Act 1978, and shall be read together with and deemed part of the Domestic Proceedings Act 1968 (hereinafter referred to as the principal Act).

That clauses 17 and 18 be a separate Bill, and that for clause 17 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Electrical Supply Authorities Association Act 1930**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Electrical Supply Authorities Association Amendment Act 1978, and shall be read together with and deemed part of the Electrical Supply Authorities Association Act 1930 (hereinafter referred to as the principal Act).

That clauses 19 and 20 be a separate Bill, and that for clause 19 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Electric Power Boards Act 1925**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Electric Power Boards Amendment Act 1978, and shall be read together with and deemed part of the Electric Power Boards Act 1925 (hereinafter referred to as the principal Act).

That clauses 21 to 23 be a separate Bill, and that for clause 21 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Factories Act 1946**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Factories Amendment Act 1978, and shall be read together with and deemed part of the Factories Act 1946 (hereinafter referred to as the principal Act).

That clauses 24 to 26 be a separate Bill, and that for clause 24 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Government Superannuation Fund Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Government Superannuation Fund Amendment Act 1978, and shall be read together with and deemed part of the Government Superannuation Fund Act 1956 (hereinafter referred to as the principal Act).

That clauses 27 and 28 be a separate Bill, and that for clause 27 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Health Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Health Amendment Act 1978, and shall be read together with and deemed part of the Health Act 1956 (hereinafter referred to as the principal Act).

That clauses 29 and 30 be a separate Bill, and that for clause 29 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Hospitals Act 1957**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Hospitals Amendment Act 1978, and shall be read together with and deemed part of the Hospitals Act 1957 (hereinafter referred to as the principal Act).

That clauses 31 and 32 be a separate Bill, and that for clause 31 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Inland Revenue Department Act 1974**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Inland Revenue Department Amendment Act 1978, and shall be read together with and deemed part of the Inland Revenue Department Act 1974 (hereinafter referred to as the principal Act).

That clauses 33 and 34 be a separate Bill, and that for clause 33 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Insolvency Act 1967**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Insolvency Amendment Act 1978, and shall be read together with and deemed part of the Insolvency Act 1967 (hereinafter referred to as the principal Act).

That clauses 35 to 37 be a separate Bill, and that for clause 35 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Invercargill Licensing Trust Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Invercargill Licensing Trust Amendment Act 1978, and shall be read together with and deemed part of the Invercargill Licensing Trust Act 1950 (hereinafter referred to as the principal Act).

That clauses 38 and 39 be a separate Bill, and that for clause 38 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Joint Council for Local Authorities Services Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Joint Council for Local Authorities Services Amendment Act 1978, and shall be read together with and deemed part of the Joint Council for Local Authorities Services Act 1977 (hereinafter referred to as the principal Act).

That clauses 40 to 43 be a separate Bill, and that for clause 40 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Judicature Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Judicature Amendment Act 1978, and shall be read together with and deemed part of the Judicature Act 1908 (hereinafter referred to as the principal Act).

That clauses 44 to 46 be a separate Bill, and that for clause 44 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Land Drainage Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Land Drainage Amendment Act 1978, and shall be read together with and deemed part of the Land Drainage Act 1908 (hereinafter referred to as the principal Act).

That clauses 47 and 48 be a separate Bill, and that for clause 47 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Licensing Trusts Act 1949**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Licensing Trusts Amendment Act 1978, and shall be read together with and deemed part of the Licensing Trusts Act 1949 (hereinafter referred to as the principal Act).

That clauses 49 to 51 be a separate Bill, and that for clause 49 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Machinery Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Machinery Amendment Act 1978, and shall be read together with an deemed part of the Machinery Act 1950 (hereinafter referred to as the principal Act).

That clauses 52 and 53 be a separate Bill, and that for clause 52 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Magistrates' Courts Act 1947**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Magistrates' Courts Amendment Act 1978, and shall be read together with and deemed part of the Magistrates' Courts Act 1947 (hereinafter referred to as the principal Act).

That clauses 54 and 55 be a separate Bill, and that for clause 54 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Margarine Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Margarine Amendment Act 1978, and shall be read together with and deemed part of the Margarine Act 1908 (hereinafter referred to as the principal Act.)

That clauses 56 and 57 be a separate Bill, and that for clause 56 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Marriage Act 1955**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Marriage Amendment Act 1978, and shall be read together with and deemed part of the Marriage Act 1955 (hereinafter referred to as the principal Act).

That clauses 58 and 59 be a separate Bill, and that for clause 58 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Masterton Licensing Trust Act 1947**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Masterton Licensing Trust Amendment Act 1978, and shall be read together with and deemed part of the Masterton Licensing Trust Act 1947 (hereinafter referred to as the principal Act).

That clauses 60 to 62 be a separate Bill, and that for clause 60 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Meat Act 1964**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Meat Amendment Act 1978, and shall be read together with and deemed part of the Meat Act 1964 (hereinafter referred to as the principal Act).

That clauses 63 to 65 be a separate Bill, and that for clause 63 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Meat Export Control Act 1921–22**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Meat Export Control Amendment Act 1978, and shall be read together with and deemed part of the Meat Export Control Act 1921–22 (hereinafter referred to as the principal Act).

**An Act to amend the Medical and Dental Auxiliaries Act 1966**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Medical and Dental Auxiliaries Amendment Act 1978, and shall be read together with and deemed part of the Medical and Dental Auxiliaries Act 1966 (hereinafter referred to as the principal Act).

**An Act to amend the Medical Practitioners Act 1968**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Medical Practitioners Amendment Act 1978, and shall be read together with and deemed part of the Medical Practitioners Act 1968 (hereinafter referred to as the principal Act).

That clauses 70 to 72 be a separate Bill, and that for clause 70 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Mutual Insurance Act 1955**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Mutual Insurance Amendment Act 1978, and shall be read together with and deemed part of the Mutual Insurance Act 1955 (hereinafter referred to as the principal Act).

That clauses 73 and 74 be a separate Bill, and that for clause 73 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the National Art Gallery, Museum, and War Memorial Act 1972**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the National Art Gallery, Museum, and War Memorial Amendment Act 1978, and shall be read together with and deemed part of the National Art Gallery, Museum, and War Memorial Act 1972 (hereinafter referred to as the principal Act).

**An Act to amend the New Zealand Society of Accountants Act 1958**

1. **Short Title**—This Act may be cited as the Wild Animal Control Amendment Act 1978, and shall be read together with and deemed part of the Wild Animal Control Act 1977 (hereinafter referred to as the principal Act).

That clauses 128 and 129 be a separate Bill, and that for clause 128 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Wool Industry Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Wool Industry Amendment Act 1978, and shall be read together with and deemed part of the Wool Industry Act 1977 (hereinafter referred to as the principal Act).

That clauses 130 and 131 be a separate Bill, and that for clause 130 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Workers' Compensation Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Workers' Compensation Amendment Act 1978, and shall be read together with and deemed part of the Workers' Compensation Act 1956 (hereinafter referred to as the principal Act).

That clauses 132 and 133 be a separate Bill, and that for clause 132 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Land Valuation Proceedings Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Land Valuation Proceedings Amendment Act 1978, and shall be read together with and deemed part of the Land Valuation Proceedings Act 1948 (hereinafter referred to as the principal Act).
