STATUTES AMENDMENT BILL

Hon. J. K. McLAY, in Committee, to move the following amendments:

That *clauses 2 and 3* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Auckland Harbour Bridge Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Auckland Harbour Bridge Amendment Act 1980, and shall be read together with and deemed part of the Auckland Harbour Bridge Act 1950 (hereinafter referred to as the principal Act).

That *clauses 4 to 6* be a separate Bill, and that for *clause 4* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Boilers, Lifts, and Cranes Act 1950**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Boilers, Lifts, and Cranes Amendment Act 1980, and shall be read together with and deemed part of the Boilers, Lifts, and Cranes Act 1950 (hereinafter referred to as the principal Act).

That *clauses 7 and 8* be a separate Bill, and that for *clause 7* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Carriage of Goods Act 1979**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Carriage of Goods Amendment Act 1980, and shall be read together with and deemed part of the Carriage of Goods Act 1979 (hereinafter referred to as the principal Act).

That *clauses 9 to 11* be a separate Bill, and that for *clause 9* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Clerks of Works Act 1944**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Clerks of Works Amendment Act 1980, and shall be read together with and deemed part of the Clerks of Works Act 1944 (hereinafter referred to as the principal Act).

That *clauses 12 to 14* be a separate Bill, and that for *clause 12* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Coal Mines Act 1979**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Coal Mines Amendment Act 1980, and shall be read together with and deemed part of the Coal Mines Act 1979 (hereinafter referred to as the principal Act).

That *clauses 15 and 16* be a separate Bill, and that for *clause 15* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Commerce Act 1975**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Commerce Amendment Act 1980, and shall be read together with and deemed part of the Commerce Act 1975 (hereinafter referred to as the principal Act).

That *clauses 17 and 18* be a separate Bill, and that for *clause 17* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Consumer Council Act 1966**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Consumer Council Amendment Act 1980, and shall be read together with and deemed part of the Consumer Council Act 1966 (hereinafter referred to as the principal Act).

That *clauses 19 to 22* be a separate Bill, and that for *clause 19* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Cook Islands Act 1915**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Cook Islands Amendment Act 1980, and shall be read together with and deemed part of the Cook Islands Act 1915 (hereinafter referred to as the principal Act).

That *clauses 23 and 24* be a separate Bill, and that for *clause 23* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Counties Insurance Empowering Act 1941**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Counties Insurance Empowering Amendment Act 1980, and shall be read together with and deemed part of the Counties Insurance Empowering Act 1941 (hereinafter referred to as the principal Act).

That *clauses 25 to 27* be a separate Bill, and that for *clause 25* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Dairy Industry Act 1952**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Dairy Industry Amendment Act 1980, and shall be read together with and deemed part of the Dairy Industry Act 1952 (hereinafter referred to as the principal Act).

That *clauses 28 and 29* be a separate Bill, and that for *clause 28* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Disabled Persons Community Welfare Act 1975**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Disabled Persons Community Welfare Amendment Act 1980, and shall be read together with and deemed part of the Disabled Persons Community Welfare Act 1975 (hereinafter referred to as the principal Act).

That *clauses 32 and 33* be a separate Bill, and that for *clause 32* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Fisheries Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Fisheries Amendment Act 1980, and shall be read together with and deemed part of the Fisheries Act 1908 (hereinafter referred to as the principal Act).

That *clauses 34 to 36* be a separate Bill, and that for *clause 34* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Gaming and Lotteries Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Gaming and Lotteries Amendment Act 1980, and shall be read together with and deemed part of the Gaming and Lotteries Act 1977 (hereinafter referred to as the principal Act).

That *clauses 37 to 39* be a separate Bill, and that for *clause 37* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Geothermal Energy Act 1953**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Geothermal Energy Amendment Act 1980, and shall be read together with and deemed part of the Geothermal Energy Act 1953 (hereinafter referred to as the principal Act).

That *clauses 40 and 41* be a separate Bill, and that for *clause 40* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Housing Act 1955**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Housing Amendment Act 1980, and shall be read together with and deemed part of the Housing Act 1955 (hereinafter referred to as the principal Act).

That *clauses 42 and 43* be a separate Bill, and that for *clause 42* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Immigration Act 1964**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Immigration Amendment Act 1980, and shall be read together with and deemed part of the Immigration Act 1964 (hereinafter referred to as the principal Act).

That *clauses 44 and 45* be a separate Bill, and that for *clause 44* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Industrial Relations Act 1973**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Industrial Relations Amendment Act 1980, and shall be read together with and deemed part of the Industrial Relations Act 1973 (hereinafter referred to as the principal Act).

That *clauses 46 and 47* be a separate Bill, and that for *clause 46* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Innkeepers Act 1962**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Innkeepers Amendment Act 1980, and shall be read together with and deemed part of the Innkeepers Act 1962 (hereinafter referred to as the principal Act).

That *clauses 48 to 50* be a separate Bill, and that for *clause 48* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Land Drainage Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Land Drainage Amendment Act 1980, and shall be read together with and deemed part of the Land Drainage Act 1908 (hereinafter referred to as the principal Act).

**An Act to amend the Licensing Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Licensing Amendment Act 1980, and shall be read together with and deemed part of the Licensing Act 1908.

**An Act to amend the Marine Reserves Act 1971**

**An Act to amend the Medical Practitioners Act 1968**

1. **Short Title**—This Act may be cited as the Vegetables Levy Amendment Act 1980, and shall be read together with and deemed part of the Vegetables Levy Act 1957 (hereinafter referred to as the principal Act).

That *clauses 134 to 136* be a separate Bill, and that for *clause 134* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Veterinary Services Act 1946**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Veterinary Services Amendment Act (No. 2) 1980, and shall be read together with and deemed part of the Veterinary Services Act 1946 (hereinafter referred to as the principal Act).

That *clauses 137 to 139* be a separate Bill, and that for *clause 137* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Water and Soil Conservation Act 1967**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Water and Soil Conservation Amendment Act 1980, and shall be read together with and deemed part of the Water and Soil Conservation Act 1967 (hereinafter referred to as the principal Act).

That *clauses 140 to 142* be a separate Bill, and that for *clause 140* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Weights and Measures Act 1925**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Weights and Measures Amendment Act 1980, and shall be read together with and deemed part of the Weights and Measures Act 1925 (hereinafter referred to as the principal Act).

That *clauses 145 and 146* be a separate Bill, and that for *clause 145* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Workers' Compensation Act 1956**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the Workers' Compensation Amendment Act 1980, and shall be read together with and deemed part of the Workers' Compensation Act 1956 (hereinafter referred to as the principal Act).
