## STATUTES AMENDMENT BILL

*Proposed Amendments*

Hon. Mr MCLAY, in Committee, to move the following amendments:

That clauses 2 to 4 be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Accident Compensation Act 1982**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Accident Compensation Amendment Act 1983, and shall be read together with and deemed part of the Accident Compensation Act 1982 (hereinafter referred to as the principal Act).

That clauses 5 and 6 be a separate Bill, and that for clause 5 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Agricultural Workers Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Agricultural Workers Amendment Act 1983, and shall be read together with and deemed part of the Agricultural Workers Act 1977 (hereinafter referred to as the principal Act).

*Clause 10:* To omit from line 29 on page 5 the word “are”, and substitute the word “were”.

To omit from line 29 on page 5 the word “is”, and substitute the word “was”.

To omit from line 30 on page 5 the word “are”, and substitute the word “is”.

To omit from line 37 on page 5 the words “Section 36 (4) of the principal Act”, and substitute the words “Section 35 (4) of the principal Act (as so substituted)”.

That clauses 9 and 10 be a separate Bill, and that for clause 9 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Building Societies Act 1965**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Building Societies Amendment Act 1983, and shall be read together with and deemed part of the Building Societies Act 1965 (hereinafter referred to as the principal Act).

That clauses 11 and 12 be a separate Bill, and that for clause 11 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Burial and Cremation Act 1964**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Burial and Cremation Amendment Act 1983, and shall be read together with and deemed part of the Burial and Cremation Act 1964 (hereinafter referred to as the principal Act).

That clauses 13 and 14 be a separate Bill, and that for clause 13 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Bush Workers Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Bush Workers Amendment Act 1983, and shall be read together with and deemed part of the Bush Workers Act 1948 (hereinafter referred to as the principal Act).

That clauses 15 to 17 be a separate Bill, and that for clause 15 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Children's Health Camps Act 1972**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Children's Health Camps Amendment Act 1983, and shall be read together with and deemed part of the Children's Health Camps Act 1972 (hereinafter referred to as the principal Act).

That clauses 18 to 20 be a separate Bill, and that for clause 18 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Criminal Justice Act 1954**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Criminal Justice Amendment Act 1983, and shall be read together with and deemed part of the Criminal Justice Act 1954 (hereinafter referred to as the principal Act).

That clauses 21 and 22 be a separate Bill, and that for clause 21 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Dangerous Goods Act 1974**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Dangerous Goods Amendment Act 1983, and shall be read together with and deemed part of the Dangerous Goods Act 1974 (hereinafter referred to as the principal Act).

That clauses 25 to 27 be a separate Bill, and that for clause 25 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Dog Control and Hydatids Act 1982**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Dog Control and Hydatids Amendment Act 1983, and shall be read together with and deemed part of the Dog Control and Hydatids Act 1982 (hereinafter referred to as the principal Act).

That clauses 28 and 29 be a separate Bill, and that for clause 28 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Domestic Protection Act 1982**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Domestic Protection Amendment Act 1983, and shall be read together with and deemed part of the Domestic Protection Act 1982 (hereinafter referred to as the principal Act).

That clauses 30 and 31 be a separate Bill, and that for clause 30 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Energy Resources Levy Act 1976**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Energy Resources Levy Amendment Act 1983, and shall be read together with and deemed part of the Energy Resources Levy Act 1976 (hereinafter referred to as the principal Act).

That clauses 32 to 34 be a separate Bill, and that for clause 32 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Explosives Act 1957**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Explosives Amendment Act 1983, and shall be read together with and deemed part of the Explosives Act 1957 (hereinafter referred to as the principal Act).

That clauses 35 and 36 be a separate Bill, and that for clause 35 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Factories and Commercial Premises Act 1981**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Factories and Commercial Premises Amendment Act 1983, and shall be read together with and deemed part of the Factories and Commercial Premises Act 1981 (hereinafter referred to as the principal Act).

That clauses 37 and 38 be a separate Bill, and that for clause 37 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Family Proceedings Act 1980**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Family Proceedings Amendment Act 1983, and shall be read together with and deemed part of the Family Proceedings Act 1980 (hereinafter referred to as the principal Act).

That clauses 39 and 40 be a separate Bill, and that for clause 39 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Fishing Vessel Ownership Savings Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Fishing Vessel Ownership Savings Amendment Act 1983, and shall be read together with and deemed part of the Fishing Vessel Ownership Savings Act 1977 (hereinafter referred to as the principal Act).

That clauses 41 and 43 be a separate Bill, and that for clause 41 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Gaming and Lotteries Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Gaming and Lotteries Amendment Act 1983, and shall be read together with and deemed part of the Gaming and Lotteries Act 1977 (hereinafter referred to as the principal Act).

That clauses 44 to 46 be a separate Bill, and that for clause 44 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Guardianship Act 1968**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Guardianship Amendment Act 1983, and shall be read together with and deemed part of the Guardianship Act 1968 (hereinafter referred to as the principal Act).

That clauses 47 to 49 be a separate Bill, and that for clause 47 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Hospitals Act 1957**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Hospitals Amendment Act 1983, and shall be read together with and deemed part of the Hospitals Act 1957 (hereinafter referred to as the principal Act).

That clauses 50 to 52 be a separate Bill, and that for clause 50 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Kitchener Memorial Scholarship Trust Act 1941**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Kitchener Memorial Scholarship Trust Amendment Act 1983, and shall be read together with and deemed part of the Kitchener Memorial Scholarship Trust Act 1941 (hereinafter referred to as the principal Act).

That clauses 53 and 54 be a separate Bill, and that for clause 53 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Legal Aid Act 1969**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Legal Aid Amendment Act 1983, and shall be read together with and deemed part of the Legal Aid Act 1969 (hereinafter referred to as the principal Act).

That clauses 55 to 57 be a separate Bill, and that for clause 55 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Life Insurance Act 1908**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Life Insurance Amendment Act (No. 2) 1983, and shall be read together with and deemed part of the Life Insurance Act 1908.

That clauses 58 and 59 be a separate Bill, and that for clause 58 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Ministry of Energy Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Ministry of Energy Amendment Act 1983, and shall be read together with and deemed part of the Ministry of Energy Act 1977 (hereinafter referred to as the principal Act).

That clauses 60 to 62 be a separate Bill, and that for clause 60 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Ministry of Transport Act 1968**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Ministry of Transport Amendment Act 1983, and shall be read together with and deemed part of the Ministry of Transport Act 1968 (hereinafter referred to as the principal Act).

That clauses 65 to 68 be a separate Bill, and that for clause 65 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Official Information Act 1982**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Official Information Amendment Act 1983, and shall be read together with and deemed part of the Official Information Act 1982 (hereinafter referred to as the principal Act).

That clauses 69 to 71 be a separate Bill, and that for clause 69 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Penal Institutions Act 1954**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Penal Institutions Amendment Act 1983, and shall be read together with and deemed part of the Penal Institutions Act 1954 (hereinafter referred to as the principal Act).

That clauses 75 and 76 be a separate Bill, and that for clause 75 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Primary Products Marketing Act 1953**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Primary Products Marketing Amendment Act 1983, and shall be read together with and deemed part of the Primary Products Marketing Act 1953 (hereinafter referred to as the principal Act).

That clauses 77, 79, and the First Schedule be a separate Bill, and that for clause 77 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Public Finance Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Public Finance Amendment Act 1983, and shall be read together with and deemed part of the Public Finance Act 1977 (hereinafter referred to as the principal Act).

That clauses 80 to 82 be a separate Bill, and that for clause 80 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Public Trust Office Act 1957**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Public Trust Office Amendment Act (No. 2) 1983, and shall be read together with and deemed part of the Public Trust Office Act 1957 (hereinafter referred to as the principal Act).

That clauses 83 to 85 be a separate Bill, and that for clause 83 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Quantity Surveyors Act 1968**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Quantity Surveyors Amendment Act 1983, and shall be read together with and deemed part of the Quantity Surveyors Act 1968 (hereinafter referred to as the principal Act).

That clauses 86 to 88 be a separate Bill, and that for clause 86 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Queen Elizabeth the Second Arts  
Council of New Zealand Act 1974**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Queen Elizabeth the Second Arts Council of New Zealand Amendment Act 1983, and shall be read together with and deemed part of the Queen Elizabeth the Second Arts Council of New Zealand Act 1974 (hereinafter referred to as the principal Act).

That clauses 89 to 91 be a separate Bill, and that for clause 89 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Queen Elizabeth the Second  
National Trust Act 1977**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Queen Elizabeth the Second National Trust Amendment Act 1983, and shall be read together with and deemed part of the Queen Elizabeth the Second National Trust Act 1977 (hereinafter referred to as the principal Act).

*Clause 93: To omit subclause (2).*

That clauses 92 and 93 be a separate Bill, and that for clause 92 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Real Estate Agents Act 1976**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Real Estate Agents Amendment Act 1983, and shall be read together with and deemed part of the Real Estate Agents Act 1976.

(2) This Act shall be deemed to have come into force on the 1st day of April 1983.

That clauses 94 and 95 be a separate Bill, and that for clause 94 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Royal New Zealand Foundation  
for the Blind Act 1963**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Royal New Zealand Foundation for the Blind Amendment Act 1983, and shall be read together with and deemed part of the Royal New Zealand Foundation for the Blind Act 1963 (hereinafter referred to as the principal Act).



That clauses 101 to 103 be a separate Bill, and that for clause 101 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Shearers Act 1962**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Shearers Amendment Act 1983, and shall be read together with and deemed part of the Shearers Act 1962 (hereinafter referred to as the principal Act).

That clauses 104 and 105 be a separate Bill, and that for clause 104 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the State Insurance Act 1963**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the State Insurance Amendment Act 1983, and shall be read together with and deemed part of the State Insurance Act 1963 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of April 1984.

That clauses 106 and 107 be a separate Bill, and that for clause 106 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Status of Children Act 1969**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Status of Children Amendment Act 1983, and shall be read together with and deemed part of the Status of Children Act 1969 (hereinafter referred to as the principal Act).

That clauses 108 to 110 be a separate Bill, and that for clause 108 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Testing Laboratory Registration Act 1972**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Testing Laboratory Registration Amendment Act 1983, and shall be read together with and deemed part of the Testing Laboratory Registration Act 1972 (hereinafter referred to as the principal Act).

That clauses 111 and 112 be a separate Bill, and that for clause 111 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Tokelau Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Tokelau Amendment Act 1983, and shall be read together with and deemed part of the Tokelau Act 1948.

That clauses 116 to 118 be a separate Bill, and that for clause 116 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Toxic Substances Act 1979**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Toxic Substances Amendment Act 1983, and shall be read together with and deemed part of the Toxic Substances Act 1979 (hereinafter referred to as the principal Act).

That clauses 119 and 120 be a separate Bill, and that for clause 119 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Valuers Act 1948**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Valuers Amendment Act 1983, and shall be read together with and deemed part of the Valuers Act 1948 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1984.

That clauses 121 and 122 be a separate Bill, and that for clause 121 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Wheat Research Levy Act 1974**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Wheat Research Levy Amendment Act 1983, and shall be read together with and deemed part of the Wheat Research Levy Act 1974 (hereinafter referred to as the principal Act).

That clauses 123 to 125 be a separate Bill, and that for clause 123 there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Wine Makers Act 1981**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Wine Makers Amendment Act (No. 2) 1983, and shall be read together with and deemed part of the Wine Makers Act 1981 (hereinafter referred to as the principal Act).
