STATUTES AMENDMENT BILL

Proposed Amendments

Hon. Geoffrey Palmer, in Committee, to move the following amendments:

That clauses 2 and 3 be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Apprenticeship Act 1983

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Apprenticeship Amendment Act 1985, and shall be read together with and deemed part of the Apprenticeship Act 1983 (hereinafter referred to as the principal Act).

That clauses 4 to 6 be a separate Bill, and that for clause 4 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Arms Act 1983

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Arms Amendment Act 1985, and shall be read together with and deemed part of the Arms Act 1983 (hereinafter referred to as the principal Act).

That clauses 7 and 8 be a separate Bill, and that for clause 7 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Chattels Transfer Act 1924

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Chattels Transfer Amendment Act 1985, and shall be read together with and deemed part of the Chattels Transfer Act 1924 (hereinafter referred to as the principal Act).

That clauses 9 to 11 be a separate Bill, and that for clause 9 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Commerce Act 1975

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Commerce Amendment Act 1985, and shall be read together with and deemed part of the Commerce Act 1975 (hereinafter referred to as the principal Act).

That clauses 12 and 13 be a separate Bill, and that for clause 12 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Contractual Mistakes Act 1977

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Contractual Mistakes Amendment Act 1985, and shall be read together with and deemed part of the Contractual Mistakes Act 1977 (hereinafter referred to as the principal Act).

That clauses 14 and 15 be a separate Bill, and that for clause 14 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Contractual Remedies Act 1979

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Contractual Remedies Amendment Act 1985, and shall be read together with and deemed part of the Contractual Remedies Act 1979 (hereinafter referred to as the principal Act).

That clauses 16 and 17 be a separate Bill, and that for clause 16 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Criminal Justice Act 1954

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Criminal Justice Amendment Act 1985, and shall be read together with and deemed part of the Criminal Justice Act 1954 (hereinafter referred to as the principal Act).

That clauses 18 and 19 be a separate Bill, and that for clause 18 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Dairy Board Act 1961

1. Short Title—This Act may be cited as the Dairy Board Amendment Act 1985, and shall be read together with and deemed part of the Dairy Board Act 1961 (hereinafter referred to as the principal Act).

That clauses 20 and 21 be a separate Bill, and that for clause 20 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Diplomatic Privileges and Immunities Act 1968

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Diplomatic Privileges and Immunities Amendment Act 1985, and shall be read together with and deemed part of the Diplomatic Privileges and Immunities Act 1968 (hereinafter referred to as the principal Act).

That clauses 22 and 23 be a separate Bill, and that for clause 22 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Disabled Persons Employment Promotion Act 1960

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Disabled Persons Employment Promotion Amendment Act 1985, and shall be read together with and deemed part of the Disabled Persons Employment Promotion Act 1960 (hereinafter referred to as the principal Act).

That clauses 24 and 25 be a separate Bill, and that for clause 24 there be substituted the following Title, enacting words, and Short Title:

An Act to amend the District Courts Act 1947

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the District Courts Amendment Act 1985, and shall be read together with and deemed part of the District Courts Act 1947 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the

1st day of April 1984.
