STATUTES AMENDMENT BILL

Proposed Motion to divide Bill into 23 Bills

Hon. D. A. M. Graham, in Committee, to move as follows:

That Part 1 and Schedule 1 be a separate Bill; and that for clause 2 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Armed Forces Discipline Act 1971 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Armed Forces Discipline Amendment Act 1997, and is part of the Armed Forces Discipline Act 1971 ("the principal Act").

That Part 2 and Schedule 2 be a separate Bill; and that for clause 6 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Births, Deaths, and Marriages Registration Act 1995

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Births, Deaths, and Marriages Registration Amendment Act 1997, and is part of the Births, Deaths, and Marriages Registration Act 1995 ("the principal Act").

That *Part 3* be a separate Bill; and that for *clause 13* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Burial and Cremation Act 1964
BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Burial and Cremation Amendment Act 1997, and is part of the Burial and Cremation Act 1964 ("the principal Act").

(2) Section 15 comes into force on 1 November 1997.

That Part 4 be a separate Bill; and that for clause 16 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Business Development Boards Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Business Development Boards Amendment Act 1997, and is part of the Business Development Boards Act 1991 ("the principal Act").

That *Part 9* be a separate Bill; and that for *clause 57* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Copyright Act 1994

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Copyright Amendment Act 1997, and is part of the Copyright Act 1994 ("the principal Act").

That *Part 10* be a separate Bill; and that for *clause 60* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Courts Martial Appeals Act 1953 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Courts Martial Appeals Amendment Act 1997, and is part of the Courts Martial Appeals Act 1953 ("the principal Act").

That *Part 11* be a separate Bill; and that for *clause 67* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Criminal Justice Act 1985
BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Criminal Justice Amendment Act 1997, and is part of the Criminal Justice Act 1985 ("the principal Act").

That Part 12 be a separate Bill; and that for clause 69 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Defence Act 1990

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Defence Amendment Act 1997, and is part of the Defence Act 1990 ("the principal Act").

That *Part 13* be a separate Bill; and that for *clause 90* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Electricity Act 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Electricity Amendment Act 1997, and is part of the Electricity Act 1992 ("the principal Act").

That Part 14 be a separate Bill; and that for clause 97 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Fair Trading Act 1986

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Fair Trading Amendment Act 1997, and is part of the Fair Trading Act 1986 ("the principal Act").

That *Part 15* be a separate Bill; and that for *clause 103* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Films, Videos, and Publications Classification Act 1993

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Films, Videos, and Publications Classification Amendment Act 1997, and is part of the Films, Videos, and Publications Classification Act 1993 ("the principal Act").

That Part 16 be a separate Bill; and that for clause 108 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Financial Reporting Act 1993 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Financial Reporting Amendment Act 1997, and is part of the Financial Reporting Act 1993 ("the principal Act").

That Part 17 be a separate Bill; and that for clause 112 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Gas Act 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Gas Amendment Act 1997, and is part of the Gas Act 1992 ("the principal Act").

That Part 18 be a separate Bill; and that for clause 116 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Government Superannuation Fund Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Government Superannuation Fund Amendment Act 1997, and is part of the Government Superannuation Fund Act 1956 ("the principal Act").

That *Part 20* be a separate Bill; and that for *clause 121* and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Legal Services Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Legal Services Amendment Act 1997, and is part of the Legal Services Act 1991 ("the principal Act").

That Part 21 be a separate Bill; and that for clause 125 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Government Act 1974

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Local Government Amendment Act 1997, and is part of the Local Government Act 1974 ("the principal Act").

That Part 22 be a separate Bill; and that for clause 127 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Ministry of Energy (Abolition) Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Ministry of Energy (Abolition) Amendment Act 1997, and is part of the Ministry of Energy (Abolition) Act 1989 ("the principal Act").

That Part 23 be a separate Bill; and that for clause 129 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the New Zealand Council of Law Reporting Act 1938

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Council of Law Reporting Amendment Act 1997, and is part of the New Zealand Council of Law Reporting Act 1938 ("the principal Act").

That Part 24 be a separate Bill; and that for clause 132 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Protection of Personal and Property Rights Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Protection of Personal and Property Rights Amendment Act 1997, and is part of the Protection of Personal and Property Rights Act 1988 ("the principal Act").

That Part 25 be a separate Bill; and that for clause 137 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Radiation Protection Act 1965 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Radiation Protection Amendment Act 1997, and is part of the Radiation Protection Act 1965 ("the principal Act").

That Part 26 be a separate Bill; and that for clause 139 and the headings before it there be substituted the following Title, enacting words, clause, and heading:

An Act to amend the Securities Act 1978

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Securities Amendment Act 1997, and is part of the Securities Act 1978 ("the principal Act").

That Part 27 be a separate Bill; and that for clause 149 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Valuers Act 1948

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Valuers Amendment Act 1997, and is part of the Valuers Act 1948 ("the principal Act").

That Part 28 be a separate Bill; and that for clause 153 and the headings before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Visiting Forces Act 1939

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Visiting Forces Amendment Act 1997, and is part of the Visiting Forces Act 1939 ("the principal Act").
