Proposed Motion to Divide Bill into 28 Bills

Hon TONY RYALL, in Committee, to move as follows:

That *Part 1* be a separate Bill; and that for *clause 2* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Agricultural Compounds and Veterinary Medicines Act 1997

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Agricultural Compounds and Veterinary Medicines Amendment Act 1999, and is part of the Agricultural Compounds and Veterinary Medicines Act 1997 ("the principal Act").

That *Part 2* be a separate Bill; and that for *clause 4* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Animal Identification Act 1993 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Animal Identification Amendment Act 1999, and is part of the Animal Identification Act 1993 ("the principal Act").

That Part 3 be a separate Bill; and that for clause 6 and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Armed Forces Discipline Act 1971 BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Armed Forces Discipline Amendment Act 1999, and is part of the Armed Forces Discipline Act 1971 ("the principal Act").

That Part 4 be a separate Bill; and that for clause 9 and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Biosecurity Act 1993

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Biosecurity Amendment Act 1999, and is part of the Biosecurity Act 1993 ("the principal Act").

That *Part 5* be a separate Bill; and that for *clause 15* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Conservation Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Conservation Amendment Act 1999, and is part of the Conservation Act 1987 ("the principal Act").

That *Part 6* be a separate Bill; and that for *clause 20* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Crown Minerals Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Crown Minerals Amendment Act 1999, and is part of the Crown Minerals Act 1991 ("the principal Act").

That *Part 7* be a separate Bill; and that for *clause 22* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Defence Act 1990

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Defence Amendment Act 1999, and is part of the Defence Act 1990 ("the principal Act").

That *Part 8* be a separate Bill; and that for *clause 24* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Financial Transactions Reporting Act 1996

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Financial Transactions Reporting Amendment Act 1999, and is part of the Financial Transactions Reporting Act 1996 ("the principal Act").

That Part 8A be a separate Bill; and that for clause 26A and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Flags, Emblems, and Names Protection Act 1981

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Flags, Emblems, and Names Protection Amendment Act 1999, and is

part of the Flags, Emblems, and Names Protection Act 1981 ("the principal Act").

That *Part 9* be a separate Bill; and that for *clause 27* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Government Superannuation Fund Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Government Superannuation Fund Amendment Act 1999, and is part of the Government Superannuation Fund Act 1956 ("the principal Act").

That Part 10 be a separate Bill; and that for clause 30 and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Hazardous Substances and New Organisms Act 1996

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Hazardous Substances and New Organisms Amendment Act 1999, and is part of the Hazardous Substances and New Organisms Act 1996 ("the principal Act").

That *Part 11* be a separate Bill; and that for *clause 46* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Judicature Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Judicature Amendment Act 1999, and is part of the Judicature Act 1908 ("the principal Act").

(2) This Act comes into force on the day after the day on

which it receives the Royal assent.

That Part 12 be a separate Bill; and that for clause 48 and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Law Practitioners Act 1982

BE IT ENACTED by the Parliament of New Zealand as follows:

1. **Short Title**—This Act may be cited as the Law Practitioners Amendment Act 1999, and is part of the Law Practitioners Act 1982 ("the principal Act").

That *Part 13* be a separate Bill; and that for *clause 50* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Marriage Act 1955

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Marriage Amendment Act 1999, and is part of the Marriage Act 1955 ("the principal Act").

That *Part 14* be a separate Bill; and that for *clause 55* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Meat Act 1981

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Meat Amendment Act 1999, and is part of the Meat Act 1981 ("the principal Act").

That *Part 15* be a separate Bill; and that for *clause 60* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Ministry of Energy (Abolition) Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Ministry of Energy (Abolition) Amendment Act 1999, and is part of the Ministry of Energy (Abolition) Act 1989 ("the principal Act").

That *Part 16* and the Schedules be a separate Bill; and that for *clause 62* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Mutual Assistance in Criminal Matters Act 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Mutual Assistance in Criminal Matters Amendment Act 1999, and is part of the Mutual Assistance in Criminal Matters Act 1992 ("the principal Act").

(2) This Act comes into force on the day after the day on

which it receives the Royal assent.

That *Part 17* be a separate Bill; and that for *clause 68* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the New Zealand Film Commission Act 1978

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Film Commission Amendment Act 1999, and is part of the New Zealand Film Commission Act 1978 ("the principal Act").

That *Part 18* be a separate Bill; and that for *clause 70* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Oaths and Declarations Act 1957

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Oaths and Declarations Amendment Act 1999, and is part of the Oaths and Declarations Act 1957 ("the principal Act").

That *Part 19* be a separate Bill; and that for *clause 72* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Ombudsmen Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Ombudsmen Amendment Act 1999, and is part of the Ombudsmen Act 1975 ("the principal Act").

That *Part 20* be a separate Bill; and that for *clause 74* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Public Finance Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Public Finance Amendment Act 1999, and is part of the Public Finance Act 1989 ("the principal Act").

That *Part 20A* be a separate Bill; and that for *clause 75A* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Ship Registration Act 1992

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Ship Registration Amendment Act 1999, and is part of the Ship Registration Act 1992 ("the principal Act").

That *Part 21* be a separate Bill; and that for *clause 76* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the State Sector Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. **Short Title**—This Act may be cited as the State Sector Amendment Act 1999, and is part of the State Sector Act 1988 ("the principal Act").

That Part 22 be a separate Bill; and that for clause 78 and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Summary Offences Act 1981

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Summary Offences Amendment Act 1999, and is part of the Summary Offences Act 1981 ("the principal Act").

That Part 22A be a separate Bill; and that for clause 79A and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Tokelau Act 1948

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Tokelau Amendment Act 1999, and is part of the Tokelau Act 1948.
- (2) Sections 79c to 79E come into force on the commencement of the order under section 79B (1).

(3) The rest of this Act comes into force on the day on which it receives the Royal Assent.

That *Part 23* be a separate Bill; and that for *clause 80* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Trade in Endangered Species Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Trade in Endangered Species Amendment Act 1999, and is part of the Trade in Endangered Species Act 1989 ("the principal Act").

That *Part 24* be a separate Bill; and that for *clause 82* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Weights and Measures Act 1987 BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Weights and Measures Amendment Act 1999, and is part of the Weights and Measures Act 1987 ("the principal Act").
- (2) This Act comes into force on the 28th day after the day on which it receives the Royal assent.

That *Part 25* be a separate Bill; and that for *clause 87* and the headings immediately before it there be substituted the following Title, enacting words, and clause:

An Act to amend the Wild Animal Control Act 1977
BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Wild Animal Control Amendment Act 1999, and is part of the Wild Animal Control Act 1977 ("the principal Act").
