# Supplementary Order Paper

STATE ENTERPRISES RESTRUCTURING BILL

*Proposed Motion to Divide the Bill into 18 Bills*

Hon. STAN RODGER, in Committee, to move as follows:

That *Part I* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Civil Aviation Act 1964**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Civil Aviation Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the Civil Aviation Act 1964 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1988.

That *Part II* be a separate Bill, and that for *clause 7* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Electricity Act 1968**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Electricity Amendment Act 1987, and shall be read together with and deemed part of the Electricity Act 1968 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1988.

That *Part III* be a separate Bill, and that for *clause 16A* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to extend certain powers in relation to electricity works to the Electricity Corporation of New Zealand Limited and other electricity operators**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Electricity Operators Act 1987.

(2) This Act shall come into force on the 1st day of January 1988.

That *Part IV* be a separate Bill, and that for *clause 21* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Ministry of Energy Act 1977**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Ministry of Energy Amendment Act 1987, and shall be read together with and deemed part of the Ministry of Energy Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1988.

That *Part V* be a separate Bill, and that for *clause 24B* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to regulate the provision of postal services**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Postal Services Act 1987.

(2) This Act shall come into force on the 1st day of January 1988.

That *Part VI* be a separate Bill, and that for *clause 40* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Public Works Act 1981**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Public Works Amendment Act (No. 3) 1987, and shall be read together with and deemed part of the Public Works Act 1981 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of January 1988.

That *Parts VII and VIIA* (except *clause 61A*) and the *Fourth Schedule* be a separate Bill, and that for *clause 41A* there be substituted the following Title, enacting words, Short Title and commencement clause, and heading:

**An Act to regulate the supply of telecommunication services and equipment and to provide for the licensing and regulation of radio apparatus**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Telecommunications Act 1987.

(2) Except as provided in **sections 42 (3) and 47 (2)** of this Act, this Act shall come into force on the 1st day of January 1988.

## PART I

## TELECOMMUNICATIONS

That *Part VIII and Schedule 2A and the Third Schedule* be a separate Bill, and that for *clause 62* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the State-Owned Enterprises Act 1986**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the State-Owned Enterprises Amendment Act 1987, and shall be read together with and deemed part of the State-Owned Enterprises Act 1986 (hereinafter referred to as the principal Act).

(2) Except as provided in sections 63A and 63B of this Act, this Act shall be deemed to have come into force on the 1st day of April 1987.

That *Part IX* be a separate Bill, and that for *clause 65* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Forests Act 1949**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Forests Amendment Act 1987, and shall be read together with and deemed part of the Forests Act 1949 (hereinafter referred to as the principal Act).

(2) Except as provided in sections 73 (2) and 74 (2) of this Act, this Act shall be deemed to have come into force on the 1st day of April 1987.

That *Part X* be a separate Bill, and that for *clause 83* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Forest and Rural Fires Act 1977**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Forest and Rural Fires Amendment Act 1987, and shall be read together with and deemed part of the Forest and Rural Fires Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 1st day of April 1987.

That *Part XI* be a separate Bill, and that for *clause 92* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to provide for transitional arrangements in respect of Post Office Bank Limited and to provide for the continued operation of the bonus bonds scheme**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Post Office Bank Act 1987.

(2) This Act shall be deemed to have come into force on the 1st day of April 1987.

That *Part XII* be a separate Bill, and that for *clause 99* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the State Services Conditions of Employment Act 1977**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the State Services Conditions of Employment Amendment Act (No. 3) 1987, and shall be read together with and deemed part of the State Services Conditions of Employment Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1987.

That *Part XIII* be a separate Bill, and that for *clause 113* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the State Services Act 1962**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the State Services Amendment Act 1987, and shall be read together with and deemed part of the State Services Act 1962 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1987.

That *Part XIV* be a separate Bill, and that for *clause 132* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Fire Service Act 1975**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Fire Service Amendment Act (No. 3) 1987, and shall be read together with and deemed part of the Fire Service Act 1975 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1987.

That *Part XV* be a separate Bill, and that for *clause 136* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Health Service Personnel Act 1983**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Health Service Personnel Act 1987, and shall be read together with and deemed part of the Health Service Personnel Act 1983 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1987.

That *Part XVI* be a separate Bill, and that for *clause 145* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the New Zealand Railways Corporation Act 1981**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the New Zealand Railways Corporation Amendment Act (No. 2) 1987, and shall be read together with and deemed part of the New Zealand Railways Corporation Act 1981 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1987.

That *Part XVII* be a separate Bill, and that for *clause 155* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to amend the Police Act 1958**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Police Amendment Act 1987, and shall be read together with and deemed part of the Police Act 1958 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1987.

That *Part XVIII* and the *Fifth* and *Sixth* Schedules be a separate Bill, and that for *clause 158* there be substituted the following Title, enacting words, and Short Title and commencement clause:

**An Act to repeal the Post Office Act 1955 and to make provision incidental thereto**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Post Office Act Repeal Act 1987.

(2) This Act shall come into force on the 1st day of January 1988.
