SALE OF LIQUOR AMENDMENT BILL (NO. 2)

Proposed Amendments

Hon TONY RYALL, in Committee, to move the following amendments:

Clause 1: To omit from subclause (2A) (c) (as inserted by Supplementary Order Paper No. 205) the expression "13", and substitute the expression "13 (1)".

To omit from *subclause (2A) (d)* (as inserted by Supplementary Order Paper No. 205) the expression "(A)", and substitute the expression "(1A)".

Clause 13: To omit this clause (which appears on page 8) and the amendments to it in Supplementary Order Papers No. 204 and No. 205, and substitute the following clause:

13. Conditions of on-licences—(1) Section 14 of the principal Act is amended by omitting subsection (2), and substituting the following subsection:

"(2) It is a condition of every on-licence granted in respect of a hotel or tavern that no liquor is to be sold or supplied on a Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day to any person other than—

"(a) Any person who is for the time being living on the premises, whether as a lodger or an employee of the holder, or otherwise; or

"(b) Any person who is present on the premises for the purpose of dining.

(2) Section 14 of the principal Act is amended by repealing subsections (4) to (7), and substituting the following subsections:

"(4) On granting an application for an on-licence in respect of a hotel or a tavern, the Licensing Authority or District Licensing Agency, as the case may be, must designate the whole or 1 or more parts of the premises as restricted areas or supervised areas.

"(5) On granting an application for an on-licence, the Licensing Authority or District Licensing Agency, as the case may be, may impose conditions relating to the following matters:

"(a) The days on which and the hours during which liquor may be sold:

"(b) The provision of food for consumption on the premises or conveyance:

"(c) The sale and supply of low-alcohol beverages:

"(d) The provision of assistance with or information about alternative forms of transport from the licensed premises:

"(e) Any other matter aimed at promoting the responsible

consumption of liquor:

"(f) The steps to be taken by the licensee to ensure that the provisions of this Act relating to the sale of liquor to prohibited persons are observed:

"(g) The designation of the whole or any part or parts of the premises or conveyance as a restricted area or

supervised area:

"(h) The persons or types of persons to whom liquor may be sold or supplied.

"(6) Different conditions may be imposed under subsection (5) (a) in respect of different parts of the premises or

conveyance.

"(7) In determining whether to impose conditions under subsection (5) (a) and, if so, what conditions, the Licensing Authority or District Licensing Agency, as the case may be, may have regard to the site of the premises in relation to neighbouring land use.

"(8) Subsection (5) (h) applies subject to the Human Rights Act

1993."

Clause 97: To omit from the new section 229 (ec) (as inserted by Supplementary Order Paper No. 205) the expression "(ea)", and substitute the expression "(eb)".

Clause 102: To insert, after subclause 1 (a) (as inserted by Supplementary Order Paper No. 205), the following paragraph:

(aa) The licence contained a condition prohibiting the sale and supply of liquor before 1 pm on Anzac Day; and

To insert in *subclause (1) (b)*, after the words "Easter Sunday" (as inserted by Supplementary Order Paper No. 205), the words "and after 1 pm on Anzac Day".

To insert, after subclause (2) (a) (as inserted by Supplementary Order

Paper No. 205), the following paragraph:

(aa) The licence contained a condition prohibiting the sale and delivery of liquor before 1 pm on Anzac Day; and

To insert in subclause (2) (b), after the word "sale" (in line 3 on page

40), the words "and delivery".

To insert in *subclause (2) (b)*, after the words "Easter Sunday" (as inserted by Supplementary Order Paper No. 205), the words "and after 1 pm on Anzac Day".

Clause 109: New section 116: To omit the words "licence controller" (in line 10 on page 49) and substitute the word "manager"

(in line 10 on page 42), and substitute the word "manager".

To omit the words "licence controller's" (in line 12 on page 42), and substitute the word "manager's".
