SOCIAL WELFARE REFORM BILL

Proposed Motion to Divide the Bill into 5 Bills

Hon. JENNY SHIPLEY, in Committee, to move the following motion:

That *clauses 2 to 24* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

An Act to amend the Social Security Act 1964

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Social Security Amendment Act (No. 2) 1991, and shall be read together with and deemed part of the Social Security Act 1964 (hereinafter referred to as the principal Act).

(2) Except as provided in **sections 6 (2), 19 (3), and 24 (2)** of this Act, this Act shall come into force on the 1st day of August 1991.

That *clauses 25 to 35* and the *First and Second Schedules* be a separate Bill, and that for *clause 25* there be substituted the following Title, enacting words, and clause:

An Act to amend the Social Welfare (Transitional Provisions) Act 1990

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Social Welfare (Transitional Provisions) Amendment Act (No. 2) 1991, and shall be read together with and deemed part of the Social Welfare (Transitional Provisions) Act 1990 (hereinafter referred to as the principal Act).

(2) Except as provided in **sections 31 (2) and 33 (2)** of this Act, this Act shall come into force on the 1st day of April 1992.

That *clauses 36 to 41* be a separate Bill, and that for *clause 36* there be substituted the following Title, enacting words, and clause:

An Act to amend the Disabled Persons Community Welfare Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Disabled Persons Community Welfare Amendment Act 1991, and shall be read together with and deemed part of the Disabled Persons Community Welfare Act 1975 (hereinafter referred to as the principal Act).

(2) Except as provided in **sections 38 (2) and 39 (2)** of this Act, this Act shall come into force on the 1st day of October 1991.

That *clauses 42 and 43* and the *Third Schedule* be a separate Bill, with the following Title, enacting words, and clause:

An Act to repeal the Rehabilitation Act 1941 and to make provision incidental thereto

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Rehabilitation Act Repeal Act 1991.

That *clauses 44 to 48* be a separate Bill, and that for *clause 44* there be substituted the following Title, enacting words, and clause:

An Act to amend the Inland Revenue Department Act 1974

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Inland Revenue Department Amendment Act (No. 2) 1991, and shall be read together with and deemed part of the Inland Revenue Department Act 1974 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of August 1991.
