TRANSPORT AMENDMENT BILL

Proposed Motion to Divide the Bill into 5 Bills

Hon. W. Rob Storey, in Committee, to move the following motion:

That clause 1, Part I, and the Schedule be a separate Bill, and that for clause 1 there be substituted the following Title, enacting words, and clause:

#### An Act to amend the Transport Act 1962

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Transport Amendment Act (No. 2) 1992, and shall be read together with and deemed part of the Transport Act 1962 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1992.

That Part II be a separate Bill, and that for clause 36 there be substituted the following Title, enacting words, and clause:

#### An Act to amend the Police Act 1958

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Police Amendment Act 1992, and shall be read together with and deemed part of the Police Act 1958 (hereinafter referred to as the principal Act).
  - (2) This Act shall come into force on the 1st day of July 1992.

That Part III be a separate Bill, and that for clause 53 there be substituted the following Title, enacting words, and clause:

## An Act to amend the Transport Services Licensing Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Transport Services Licensing Amendment Act (No. 2) 1992, and shall be read together with and deemed part

of the Transport Services Licensing Act 1989 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1992.

That Part IV be a separate Bill, and that for clause 58 there be substituted the following Title, enacting words, and clause:

An Act to amend the Transit New Zealand Act 1989
BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Transit New Zealand Amendment Act 1992, and shall be read together with and deemed part of the Transit New Zealand Act 1989 (hereinafter referred to as the principal Act).
  - (2) This Act shall come into force on the 1st day of July 1992.

That *Part V* be a separate Bill, and that for *clause 74* there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Government Act 1974
BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Local Government Amendment Act (No. 2) 1992, and shall be read together with and deemed part of the Local Government Act 1974 (hereinafter referred to as the principal Act).
  - (2) This Act shall come into force on the 1st day of July 1992.
