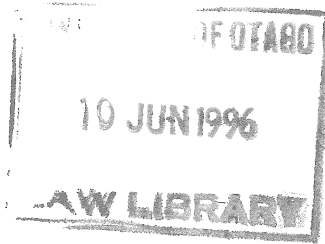

# Supplementary Order Paper

Tuesday, 30 April 1996

TAX REDUCTION AND SOCIAL POLICY BILL

*Proposed Motion to Divide Bill into 5 Bills*

Rt. Hon. W. F. BIRCH, in Committee, to move the following motion:

That *Part I* and the *First to Fifth Schedules* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

### **An Act to amend the Income Tax Act 1994**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Income Tax Act 1994 Amendment Act 1996, and shall be read together with and deemed part of the Income Tax Act 1994 (hereinafter referred to as the principal Act).

That *Part II* be a separate Bill, and that for *clause 57* there be substituted the following Title, enacting words, and clause:

### **An Act to amend the Income Tax Act 1976**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Income Tax Act 1976 Amendment Act 1996, and shall be read together with and deemed part of the Income Tax Act 1976 (hereinafter referred to as the principal Act), and that Act shall, in respect of matters to which it applied before its repeal by section YB 3 of the Income Tax Act 1994, be read as amended by the provisions of this Act.

That *Part III* be a separate Bill, and that for *clauses 61 and 62* there be substituted the following Title, enacting words, and clause:

### **An Act to amend the Tax Administration Act 1994**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Tax Administration Amendment Act 1996, and shall be read together with and deemed part of the Tax Administration Act 1994 (hereinafter referred to as the principal Act).

(2) Except as provided in sections 66 (4), 67 (4), 68 (4), and 69 (3) of this Act, this Act shall come into force on 1 July 1996.

That *Part IV* and the *Sixth to Ninth Schedules* be a separate Bill, and that for *clauses 79 and 80* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Social Security Act 1964**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Social Security Amendment Act 1996, and shall be read together with and deemed part of the Social Security Act 1964 (hereinafter referred to as the principal Act).

(2) Except as provided in sections 81 (8), 104 (2), 106 (2), 108 (2), 110 (2), 111 (5), 117 (2), 118 (2), 119 (3), 120 (2), 124 (3), and 125 (2) of this Act, this Act and the **Seventh and Eighth Schedules** to this Act and **Part II of the Ninth Schedule** to this Act shall come into force on the 1st day of April 1997.

That *Part V* and the *Tenth Schedule* be a separate Bill, and that for *clauses 126 and 127* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Social Welfare (Transitional Provisions) Act 1990**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Social Welfare (Transitional Provisions) Amendment Act 1996, and shall be read together with and deemed part of the Social Welfare (Transitional Provisions) Act 1990 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1996.
