TAXATION REFORM (NO. 6) BILL

*Proposed Motion to Divide Bill into 6 Separate Bills*

Hon. DAVID CAYGILL, in Committee, to move as follows:

That clauses 2 to 49 and the Schedule be a separate Bill, and that for clause 2 there be substituted the following Title, enacting words, and clause:

**An Act to amend the Income Tax Act 1976**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Income Tax Amendment Act (No. 10) 1989, and shall be read together with and deemed part of the Income Tax Act 1976 (hereinafter referred to as the principal Act).

(2) Except as this Act otherwise provides, this Act shall come into force on the day on which this Act receives the Royal assent.

That clauses 50 to 84 be a separate Bill, and that for clause 50 there be substituted the following Title, enacting words, and clause:

**An Act to amend the Land Tax Act 1976**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and application**—(1) This Act may be cited as the Land Tax Amendment Act (No. 4) 1989, and shall be read together with and deemed part of the Land Tax Act 1976 (hereinafter referred to as the principal Act).

(2) This Act shall apply with respect to the land tax for the year of payment commencing on the 1st day of April 1990 and for every subsequent year.

That clauses 85 to 101 be a separate Bill, and that for clause 85 there be substituted the following Title, enacting words, and clause:

**An Act to amend the Goods and Services Tax Act 1985**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Goods and Services Tax Amendment Act (No. 6) 1989, and shall be read together with and deemed part of the

Goods and Services Tax Act 1985 (hereinafter referred to as the principal Act).

(2) Except as this Act otherwise provides, this Act shall come into force on the day on which this Act receives the Royal assent.

That clauses 102 and 103 be a separate Bill, and that for clause 102 there be substituted the following Title, enacting words, and clause:

**An Act to amend the Estate and Gift Duties Act 1968**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Estate and Gift Duties Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Estate and Gift Duties Act 1968 (hereinafter referred to as the principal Act).

That clauses 104 to 108 be a separate Bill, and that for clause 104 there be substituted the following Title, enacting words, and clause:

**An Act to amend the Stamp and Cheque Duties Act  
1971**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and application**—(1) This Act may be cited as the Stamp and Cheque Duties Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Stamp and Cheque Duties Act 1971 (hereinafter referred to as the principal Act).

(2) This Act shall apply to any instrument executed on or after the day on which this Act receives the Royal assent.

That clauses 109 and 110 be a separate Bill, and that for clause 109 there be substituted the following Title, enacting words, and clause:

**An Act to amend the Inland Revenue Department Act  
1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Inland Revenue Department Amendment Act (No. 3) 1989, and shall be read together with and deemed part of the Inland Revenue Department Act 1974 (hereinafter referred to as the principal Act).
