TAXATION REFORM BILL (NO. 7)

*Proposed Motion to Divide the Bill into 5 Bills*

Hon. PETER NEILSON, in Committee, to move the following motion:

That *Part I* and the Schedule be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Income Tax Act 1976**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Income Tax Amendment Act (No. 2) 1990, and shall be read together with and deemed part of the Income Tax Act 1976 (hereinafter referred to as the principal Act).

(2) Except as this Act otherwise provides, this Act shall come into force on the day on which this Act receives the Royal assent.

That *Part II* be a separate Bill, and that for *clause 62* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Goods and Services Tax Act 1985**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Goods and Services Tax Amendment Act 1990, and shall be read together with and deemed part of the Goods and Services Tax Act 1985 (hereinafter referred to as the principal Act).

(2) Except where this Act otherwise provides, this Act shall come into force on the day on which this Act receives the Royal assent.

That *Part IV* be a separate Bill, and that for *clause 78* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Unclaimed Money Act 1971**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Unclaimed Money Amendment Act 1990, and shall be read together with and deemed part of the Unclaimed Money Act 1971 (hereinafter referred to as the principal Act).

That *Part V* be a separate Bill, and that for *clause 80* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Inland Revenue Department Act 1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Inland Revenue Department Amendment Act 1990, and shall be read together with and deemed part of the Inland Revenue Department Act 1974 (hereinafter referred to as the principal Act).

That *Part VI* be a separate Bill, and that for *clause 82* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Superannuation Schemes Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Superannuation Schemes Amendment Act 1990, and shall be read together with and deemed part of the Superannuation Schemes Act 1989 (hereinafter referred to as the principal Act).
