Taxation (Annual Rates, Business Taxation, KiwiSaver, and Remedial Matters) Bill

Proposed motion to divide Bill into 3 Bills

Hon Peter Dunne, in Committee, to move the following:

That *clause 3* and the *heading before clause 3* be a separate Bill, and that for the *heading before clause 3* there be substituted the following enacting words, Title clause and Commencement clause:

#### The Parliament of New Zealand enacts as follows:

#### 1 Title

This Act is the Taxation (Annual Rates of Income Tax 2007–08) Act 2007.

#### 2 Commencement

This Act comes into force on the day on which it receives the Royal assent.
