UNITED NATIONS CONVENTION ON THE LAW OF THE SEA BILL

Proposed Motion to Divide Bill into 12 Separate Bills

Rt Hon. DON MCKINNON, in Committee, to move as follows:

That *Parts I to III* be a separate Bill, with the following Title, enacting words, and Short Title clause:

An Act to complete the implementation in the law of New Zealand of the United Nations Convention on the Law of the Sea

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the United Nations Convention on the Law of the Sea Act 1996.

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 17 and 18* be a separate Bill, and that for *clause 17* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Acts Interpretation Act 1924

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Acts Interpretation Amendment Act 1996, and shall be read together with and deemed part of the Acts Interpretation Act 1924 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 19 to 22* be a separate Bill, and that for *clause 19* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Continental Shelf Act 1964

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Continental Shelf Amendment Act 1996, and shall

be read together with and deemed part of the Continental Shelf Act 1964 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 23 to 30* be a separate Bill, and that for *clause 23* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Customs Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Customs Amendment Act **1996**, and shall be read together with and deemed part of the Customs Act 1966 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 31 and 32* be a separate Bill, and that for *clause 31* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Diplomatic Privileges and Immunities Act 1968

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Diplomatic Privileges and Immunities Amendment Act **1996**, and shall be read together with and deemed part of the Diplomatic Privileges and Immunities Act 1968 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 35 to 39* be a separate Bill, and that for *clause 35* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Territorial Sea and Exclusive Economic Zone Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Territorial Sea and Exclusive Economic Zone Amendment Act **1996**, and shall be read together with and deemed part of the Territorial Sea and Exclusive Economic Zone Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 42 to 44* be a separate Bill, and that for *clause 42* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Immigration Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Immigration Amendment Act **1996**, and shall be read together with and deemed part of the Immigration Act 1987 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 45 and 46* be a separate Bill, and that for *clause 45* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Radiocommunications Act 1989

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Radiocommunications Amendment Act 1996, and shall be read together with and deemed part of the Radiocommunications Act 1989 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 47 and 48* be a separate Bill, and that for *clause 47* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Crown Minerals Act 1991

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Crown Minerals Amendment Act 1996, and shall be read together with and deemed part of the Crown Minerals Act 1991 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 49 and 50* be a separate Bill, and that for *clause 49* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Biosecurity Act 1993

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Biosecurity Amendment Act 1996, and shall be read together with and deemed part of the Biosecurity Act 1993 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 51 to 53* be a separate Bill, and that for *clause 51* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Maritime Transport Act 1994

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Maritime Transport Amendment Act 1996, and shall be read together with and deemed part of the Maritime Transport Act 1994 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the **1st day of August 1996**.

That *clauses 54 to 57* be a separate Bill, and that for *clause 54* there be substituted the following Title, enacting words, and Short Title clause:

An Act to amend the Customs and Excise Act 1996

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Customs and Excise Amendment Act 1996, and shall be read together with and deemed part of the Customs and Excise Act 1996 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

EXPLANATORY NOTE

This Supplementary Order Paper contains the appropriate motion to divide the United Nations Convention on the Law of the Sea Bill into 12 separate Bills: United Nations Convention on the Law of the Sea Bill, Acts Interpretation Amendment Bill, Continental Shelf Amendment Bill, Customs Amendment Bill, Diplomatic Privileges and Immunities Amendment Bill, Territorial Sea and Exclusive Economic Zone Amendment Bill, Immigration Amendment Bill, Radiocommunications Amendment Bill, Crown Minerals Amendment Bill, Biosecurity Amendment Bill, Maritime Transport Amendment Bill, and Customs and Excise Amendment Bill.
