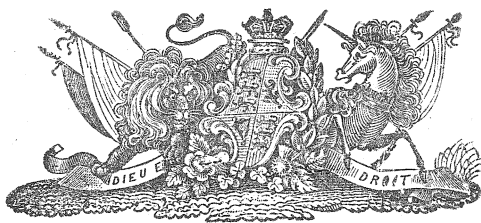

*An ACT to appropriate the Revenue of the Province of Marlborough to the Thirtieth Day of June, one thousand eight hundred and sixty-one.* Title

**B**E it enacted, by the Superintendent of the Province of Marlborough, with the advice and consent of the Provincial Council thereof, as follows:— Enacting Clause.

1. Out of the revenue of the Province of Marlborough, subject to appropriation by the Superintendent and Provincial Council thereof, there may be issued and applied any sums of money not exceeding the several sums hereinafter specified: That is to say—for defraying the charge of the Government of the said Province for the year ending the thirtieth day of June, one thousand eight hundred and sixty-one, the sum of twenty-one thousand and eight pounds fifteen shillings:—

2. The Provincial Treasurer shall issue and pay from time to time any sum or sums of money for the purposes hereinbefore mentioned, not exceeding in the whole the sums respectively specified to such persons, and in such portions as the Superintendent for the time being shall by warrants to be granted by him from time to time direct; and such Treasurer shall, in his accounts, be allowed credit for all sums paid by him in pursuance of such warrants, and the receipts of the persons to whom such sums shall have been so paid, shall be to him a full discharge for the sums for which such receipts shall have been given, and the amounts thereof shall be passed to his credit in account accordingly.

Treasurer to pay money on the warrant of Superintendent.

3. And whereas certain expenses have been incurred for the period commencing on the first day of November, one thousand eight hundred and fifty-nine, and ending the thirtieth day of June, one thousand eight hundred and sixty, for the purposes hereinafter mentioned, amounting to the sum of two thousand five hundred and twenty-two pounds one shilling and one penny: Be it therefore enacted, that the Provincial Treasurer shall, in his accounts, be allowed credit for all sums not exceeding in the whole the sums hereinafter specified, paid to such persons and in such portions as the Superintendent shall by any warrant or warrants under his hand have directed or may direct; that is to say—
