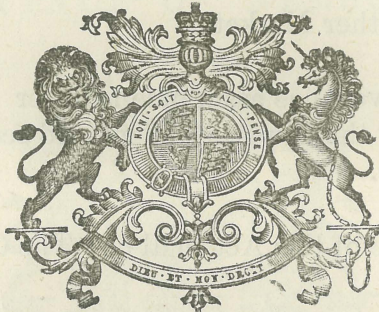

AN ACT to enable the Superintendent to transfer certain lands to the Title.
Corporation of the City of Nelson.

[Assented to June 9, 1874.]

WHEREAS the several pieces or parcels of land particularly Preamble.
described in the Schedule to this Act have been granted to the
Superintendent of the Province of Nelson under "The Public Reserves
Act 1854" to hold the same respectively in trust for Cattle Fish and
other Markets : AND WHEREAS it is expedient that the Superintendent
should be empowered to dispose of and transfer the said several pieces
or parcels of land in manner hereinafter mentioned :

Be it therefore enacted by the Superintendent of the Province of
Nelson by and with the advice and consent of the Provincial Council
thereof as follows :—

1. It

Superintendent may transfer Reserves to Corporation of City of Nelson

1. It shall be lawful for the Superintendent by and with the advice and consent of his Executive Council to convey assure transfer and dispose of to the Mayor Councillors and Citizens of the City of Nelson the two several pieces or parcels of land particularly mentioned and described in the Schedule to this Act To Hold the same in trust for Cattle Fish and other Markets.

Form of Transfer.

2. Every such conveyance assurance transfer and disposition shall be by deed signed by the Superintendent and sealed with the Public Seal of the Province.

Short Title.

3. The Short Title of this Act shall be "The City Reserves Transfer Act 1874."

SCHEDULE.

All that piece or parcel of land containing by admeasurement Ten Acres more or less situated in the City of Nelson in the Province of Nelson and marked A on the plan drawn in the margin of the Grant thereof to the Superintendent of the Province of Nelson and his Successors dated the Ninth day of February in the year of our Lord one thousand eight hundred and fifty-six and made and signed by Colonel Thomas Gore Browne C.B. then Governor of New Zealand and which piece or parcel of land is bounded on the Northward by land granted to Edmund Buxton 1100 links on the Eastward by Nga-ti-tama Street 925 links on the Southward by a Public Road 1100 links and on the Westward by the Waimea Road 925 links : AND ALSO all that piece or parcel of land containing by admeasurement Two Roods more or less situated in the City of Nelson aforesaid and marked O on the plan drawn in the margin of the said grant and bounded towards the North-east by the Haven Road towards the North-west by Hastings Street towards the East and South by Mud Flat and towards the West by land granted to William Taylor and which said pieces or parcels of land are more particularly delineated on the plan drawn in the margin of the said grant.
